## ATTENTION OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in the Rules Applying to Dog Shows, Chapter 11, Section 1.

Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, *regardless of whether the dog earned any points or awards*. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. # AKC National Owner-Handled Series

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

*\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

### **NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES**

**NR1.08100.20800 Veteran Classes** - Class for dogs & class for bitches seven (7) years & under ten (10) years old.

**NR1.08100.37050 Veteran Classes** - Class for dogs & class for bitches ten (10) years & under thirteen (13) years old.

**NR1.08100.48500 Veteran Classes** - Class for dogs & class for bitches thirteen (13) years & over

Neutered dogs and spayed bitches may be entered in the Veteran classes. Winners of the above classes are eligible for Best of Breed Competition.

### **00900. Best of Breed Competition**

### **NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES**

**(provided for both dogs & bitches, including neutered dogs and spayed bitches as written below.)**

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won these classes.

**NR2.09100. Stud Dog Class** - For Stud Dogs and two of their Get. The Get do not need to be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in the Best of Breed Competition. The Get MUST be entered in one of the regular classes or if Champions of Record, in the Best of Breed Competition. The Stud Dog shall be considered as one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get. A neutered male may be entered as a Stud Dog in the Stud Dog Class.

**NR2.09200. Brood Bitch Class** - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get. A spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class.

**NR2.09300. Brace** - Two dogs of the same Breed with one or more common owner(s) and both dogs must be entered in another class, or if a Champion of Record, in the Best of Breed competition and presented by a maximum of two handlers. - The dogs comprising a Brace MUST be named at time of entry. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class Only". In making entries for "Brace Class Only", full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as a part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No. 1," "Brace No. 2," etc.

**NR2.09400. Team Class** - Four dogs of the same Breed with one or more common owner(s) and all dogs must be entered in another class or as Champion of Record in the Best of Breed competition and presented by a maximum of four handlers. The dogs comprising a Team must be named at the time of entry and the Team Class noted in the space provided for Additional Classes. All dogs entered in Team Class must also be entered in a Regular Class or for Best of Breed Competition. There will be no additional fee for Team Classes if more than one Team is entered by the same owner, the dogs comprising each team must be so designated, "Team No. 1," "Team No. 2," etc.

**NR2.44800. Grandsire Class** - Class offered for the grandsire and two consecutive generations of his Get. While the consecutive generations (e.g. Get and Grand-Get) must be entered in another class or as Champion of Record in the Best of Breed competition, only the Grandsire must be identified at the time of entry. The grandsire need not be entered in another class, nor does he need to be intact. Handlers of the Grandsire and all generations being exhibited must wear armbands.

**NR2.44900. Granddam Class** - Same as for the Grandsire except substitute Granddam for Grandsire and Produce for Get.

### **\*\*\*NATIONAL SPECIALTY POINTS FOR RESERVE\*\*\***

At the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held. No major for Reserve Winners shall be given based upon an award of Best of Winners. In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included.

## PARADE OF COMPANIONS

There will be a non-competitive class Parade of Companions for Canaan Dogs (dogs & bitches). These dogs do not have to be AKC registered (unless otherwise specified) to participate. Participants may include Champions, Rescue Dogs, AKC Performance Titled (AKC/CDCA). Performance Titles (herding, rally, agility, obedience or tracking).

DO NOT ENTER THROUGH SUPERINTENDENT - COMPLETE THE FORM BELOW AND MAIL AS DIRECTED. Neutered dogs and spayed bitches may be entered. A Rosette will be awarded to each entrant.

### AKC BOARD POLICY MANUAL

#### Grooming Space (July 2012 Board meeting; amended December 2015)

It is the policy of the AKC to encourage and welcome all exhibitors. Keeping the cost of participating in the Sport reasonable for current as well as potential new competitors is crucial to its future health and growth. At the same time, the Board recognizes the financial pressure faced by many clubs in putting on their events. The Board has therefore established the following policy, effective January 1, 2013, with regard to grooming space:

All clubs are required to set aside an area designated for grooming/crating. “Day of event” grooming must be provided that is reasonable in relation to entry of the show. A club holding a conformation event may, at its option, offer reserved grooming/crating space for a fee, provided that it makes available, at no charge in addition to the entry fee for the show, a reasonable amount of grooming/crating space of equal desirability to the exhibitors. Such free space need not include additional services such as the availability of electrical hookups.

In keeping with AKC Policy, and to provide for the comfort and safety of both exhibitors and dogs, the Virginia Spring Fling Cluster will have crating/grooming areas as outlined below.

**DAY OF EVENT CRATING/GROOMING. FREE. NO ELECTRIC.** Limited space. Show committee may direct placement of equipment, may require that crates be stacked and may limit chairs in Day of Event Crating/Grooming. All equipment must be removed at the end of each day’s show.

**OPEN GROOMING. FREE. NO ELECTRIC.** Limited space with predetermined layout of aisles and crates. Show committee may require that crates be stacked. Equipment may remain in the building overnight Wednesday - Saturday nights but must be removed one hour after BIS Sunday. Dogs in Open Grooming may NOT remain overnight.

**PRIME (RESERVED) GROOMING. FEES INCLUDE ELECTRIC.** Limited space. See All-Breed Premium List for sizes, fee information and reservation form. Equipment may remain in the building overnight Wed-Sat nights but must be removed one hour after BIS Sunday. Dogs in Reserved Grooming **MAY** remain overnight with crate tags and signed release form.

An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)**

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Entry Fees** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management, it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. **No Refund for Duplicate Entries.** Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made. **An Administrative Fee of \$5.00 will be charged or withheld from refunds for duplicate entries.**

**An Administrative Fee of \$5.00 will be withheld** from all refunds for entries cancelled prior to the closing of entries.

**As specified in Chapter 12, Section 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

**Dogs May Arrive** any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

**Judges Will Not Wait for Any Dog Holding Up a Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**All Dogs Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**Class Cash Prizes** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent's Office advised at once. The Superintendent and Show-Giving Club disclaim any liability for cash prizes after the judging of the breed is over.

**No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
