# Virginia Spring Fling Crating/Grooming Availability

AKC BOARD POLICY MANUAL
Grooming Space (July 2012 Board meeting; amended December 2015)

It is the policy of the AKC to encourage and welcome all exhibitors. Keeping the cost of participating in the Sport reasonable for current as well as potential new competitors is crucial to its future health and growth. At the same time, the Board recognizes the financial pressure faced by many clubs in putting on their events. The Board has therefore established the following policy, effective January 1, 2013, with regard to grooming space:

All clubs are required to set aside an area designated for grooming/crating. "Day of Event" grooming must be provided that is reasonable in relation to entry of the show. A club holding a conformation event may, at its option, offer reserved grooming/crating space for a fee, provided that it makes available, at no charge in addition to the entry fee for the show, a reasonable amount of grooming/crating space of equal desirability to the exhibitors. Such free space need not include additional services such as the availability of electrical hookups.

In keeping with AKC Policy, and to provide for the comfort and safety of both exhibitors and dogs, the Virginia Spring Fling Cluster will have crating/grooming areas as outlined below.

DAY OF EVENT CRATING/GROOMING. **FREE. NO ELECTRIC.** Limited space. Show committee may direct placement of equipment, may require that crates be stacked and may limit chairs in Day of Event Crating/Grooming. All equipment must be removed at the end of each day's show.

OPEN GROOMING. **FREE. NO ELECTRIC.** Limited space with predetermined layout of aisles and crates. Show committee may require that crates be stacked. Equipment may remain in the building overnight Wednesday - Saturday nights but must be removed one hour after BIS Sunday. Dogs in Open Grooming may NOT remain overnight.

PRIME (RESERVED) GROOMING. **FEES <u>INCLUDE</u> ELECTRIC.** Limited space. See page 10 for sizes, fee information and reservation form. Equipment may remain in the building overnight Wednesday - Saturday nights but must be removed one hour after BIS Sunday. Dogs in Reserved Grooming **MAY** remain overnight with crate tags and signed release form.

### **Notice to Exhibitors**

Vehicle lights must be left on while loading and unloading.

With the exception of Handicapped and official club business, motorized scooters will not be allowed in the building.

The kennel clubs are not responsible for the actions or products of the commercial vendors at these events.

We highly recommend that you do not leave dogs unattended in cars, exercise pens or motor homes; and we suggest that you secure your crates for the safety of your dogs.

No retractable/flexible leads allowed in the building.

NO SAVING OF PARKING SPACES, EXCEPT FOR PAID RESERVED PRIME PARKING.

**Handlers & Exhibitors** will be responsible for the actions of their dogs and maintaining control of their dogs. **Bathing Stations** will be available outside.

For the safety of all participants and dogs, children must be under the direct control and supervision of their parents at all times. Adults who fail to properly supervise children under their care may be subject to Event Committee Hearing. Baby strollers are not allowed in the building. 4-Wheeled wagon-type carts used to transport children are not permitted in the building unless they are completely enclosed.

THE CLUSTER RESERVESTHE RIGHTTO REMOVE ANY ANIMAL IN DISTRESS FROM A PARKED VEHICLE OR CRATE, AND ALL PERSONS ATTENDING THESE DOG EVENTS HEREBY WAIVE ANY CLAIM FOR DAMAGES AGAINST THE CLUBS FOR SUCH REMOVAL.

**All Dogs** must be removed no later than one hour after Best in Show on Sunday. Equipment may remain in the building, but may be shifted to allow for cleaning.

Building will open at approximately 3:00 P.M. Wednesday for general exhibitors, OR when set up is completed, at the discretion of the Cluster Committee. Vendors and show personnel may set up earlier at the discretion of the Cluster Committee.

Doors locked from 10:00 P.M. to 6:00 A.M.

Parking Fee: \$5.00 per car per day, \$15.00 for 4 day pass.

Crate identification labels and contact numbers are recommended for all crates and are required for dogs in building overnight.

Ample trash cans & bins will be available in the show areas. Please help us keep the show grounds clean. Exhibitors & handlers will be responsible for clean conditions in and around their crates & vehicles. NO SPACE FOR UNENTERED DOGS. NO OVERNIGHT CRATED DOGS EXCEPT THOSE IN RESERVED GROOMING SPACE WITH SIGNED RELEASE FORM.

NO PRIVATE X-PENS INSIDE. NO SOFT SIDED CRATES.

RINGSIDE OR AISLE CRATING LIMITED TO 15 MINUTES PRIOR TO SCHEDULED RING TIME. CRATES AND OTHER ITEMS MUST BE REMOVED IMMEDIATELY AFTER COMPETITION OF BREED AND/OR GROUP JUDGING. NO SCISSORING OR SPRAYING OF PRODUCT PERMITTED RINGSIDE. ABSOLUTELY NO SHAVINGS IN PRIVATE X-PENS OUTSIDE OR ON GROUNDS WITHOUT SITE CONTROL APPROVAL.

\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

**NOVICE SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

MASTER CLASS: This class will be for Boys and Girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

# Attention Owners/Exhibitors of Foreign Registered Dogs

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1.

Most important to note are the following:

- Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
- 2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at: http://images.akc.org/pdf/extenap.pdf

- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
