

# Driving-Under-the-Influence (DUI) Medication Assisted Treatment (MAT) Integration/Outreach Pilot Project

# Polysubstance Use Disorder

The DUI MAT Integration/Outreach Pilot Project targets the development and implementation of a recognition and intervention pilot program for Opioid Use Disorder (OUD) and Polysubstance Use Disorder (SUD) to benefit DUI program participants.

DUI MAT services include education, pre-screens and 2nd level screenings, treatment referrals, and counseling support.

DUI MAT is a voluntary program and will not impact your DUI program or any legal proceedings.

## Benefits

- *The DUI MAT program is separate from your DUI Program Requirements and is confidential.*
- *Your participation will not affect your DUI court case, probation requirements or your status with the DMV.*
- *As a participant, you will receive an assessment which will determine the treatment resources that may benefit you.*



## What is Polysubstance Abuse?

Poly drug use refers to combined drug intoxication to achieve a particular effect. In many cases one drug is used as a base, or primary drug, with additional drugs to lessen or compensate for the side effects of the primary drug and make the experience more enjoyable with drug synergy effects, or to supplement for the primary drug when supply is low.

This can include any two substances that create a dependency or negative impact in your life! Examples include alcohol and marijuana, alcohol and prescription medication, methamphetamine and alcohol. Any two substances used together can result in a Polysubstance use disorder. Although Medication-Assisted Treatment (MAT) may not be appropriate to treat this issue, there are multiple treatment options available.

## Is the DUI MAT Program Right for You?

DUI MAT is for anyone currently enrolled in a participating DUI Program who may have a substance abuse problem. While the project was developed to address the opioid crisis, ***you do not need to be exclusively dependent on opioids to participate in the DUI MAT program.*** Alcohol in combination with any other drug qualifies for DUI MAT.

The first step to determining eligibility is to complete the pre-screen provided to you by your DUI Program. If addiction is indicated, you will be referred to a 2nd level assessment at no charge to you. Upon completion of the 2nd level assessment you will meet with a counselor certified in Substance Use Disorder. The counselor will provide you with treatment referrals.

Once you are enrolled in DUI MAT, you will meet with the counselor on a regular basis as you complete your treatment program. You may continue receiving counseling services after your DUI Program has ended. DUI MAT will be available at select service locations through September 2020.
