# TMBCI INSTITUTIONAL REVIEW BOARD

# What is an Instituation Review Board?

An Institutional Review Board (IRB) is a committee established to review and approve research involving human subjects. The purpose of the IRB is to ensure that all human subject research be conducted in accordance with all tribal, federal, institutional, and ethical guidelines.

# Who participates in the IRB?

The TMBCI IRB is a board that is sanctioned by the TMBCI tribe and Tribal Nations Research Group oversees the board. The board consists of highly knowledgeable individuals such at scientists, doctorates, community members, cultural advisor, and community health representatives. All board members are voluntary and do not receive compensation for their time.

# When are the IRB board meetings?

All IRB applications have to be received by the 28<sup>th</sup> of each month to be reviewed for the following board meeting which is on the 2<sup>nd</sup> Wednesday of each month. There is a two week window between application deadline and IRB meeting to give the board sufficient time to review documents.



Dr. Azure completed her internship at the Indian Health Care Resource Center in Tulsa in OK; and prior to that completed training placements at the Turtle Mountain Community School focusing on K-12 student assessments. She began employment with Indian Health Service in April 2014 and is currently employed as a Clinical Psychologist. Over the last five years, she also contracts her services with the Turtle Mountain Vocational Rehabilitation Project and for the last two years with the Turtle Mountain Community School District #7 providing psychological assessments. Dr. Azure provides therapy to all age groups through individual and group therapy; and clinical assessments in the areas of personality, learning disabilities, ADHD, intellectual disabilities, and autism spectrum disorders. Her area of specialty includes depression, anxiety, anger, defiant behaviors, suicidal ideation, self-injurious behaviors, and psychological assessment. She is also a part of the Turtle Mountain Suicide Prevention Team, Heaven's Angels Infant Bereavement Support Group, and the Tribal Nations Research Group. ### TMBCI RESEARCH PROTECTION ACT

The TMBCI Research Protection Act was signed into law by TMBCI resolution on July 31, 2014. All research conducted on the TMBCI Reservation and TMBCI Tribal Lands are required to adhere to the Act. The Purpose of the act is:

- to protect the people, culture, and natural resources of the Tribe and the Tribe's future generations from unauthorized scientific research;
- to reduce any adverse effects of human subject research and related activities on the Tribe and its People;
- to ensure that researchers recognize the Tribe's control of research activities and ownership of all data and information generated or produced by such research;
- and to establish and provide a statutory basis for a process to review and govern any research, collection, database, or publication undertaken on the Reservation.
