PERKINS RE-AUTHORIZATION

The Carl D. Perkins Career and Technical Education Act (Perkins IV) is due for re-authorization. The US House of Representatives passed House Resolution 2353, their version of the new Career and Technical Education law, and forwarded it to the Senate, which sent it to their HELP Committee (Health, Education, Labor and Pensions) to address any changes or additions needed.

Because H.R. 2353 does not specify Family and Consumer Sciences as a permissible use of funds, The Coalition has initiated an advocacy campaign to ensure Family and Consumer Sciences is specified in the final version. Actions to take:

- Build an on-going relationship with your Senators and Representatives by speaking out on topics they're working on. [Find your Senators and how to connect online.](#) [Find your Representative and how connect.](#)
- Watch for alerts from The Coalition or one of its partner organizations. Reach out to legislators to encourage them to take action!
