Approval of Cost Correction for ESO Conference:

Director Schelstreet stated that the originally submitted requested had the wrong dates for the conference. There is one additional day of expenses totaling \$361.

Motion to approve the ESO Conference cost correction was made by Chief Keegan and seconded by Chief Hansen.

The motion passed by roll call vote. (6 yea, 0 nay, 5 absent)

Approval of Cyber Security Quote:

Mark Marzetta, Tri-Com IT Manager, presented the RFP quotes for Cyber Security. He reviewed the criteria used to evaluate the quotes including products offered and prices.

Director Schelstreet stated that when Mission Critical Partners did the cyber security assessment they recommended a system that recognizes when something is abnormal and is monitored 24/7/365. Needed a company that offered all components. CrowdStrike was the only one that offered all of the EDR, MDR, XDR components without other companies supplying portions. \$50,000 was budgeted for this.

Chief Keegan asked about insurance for ransomware, etc. Tri-Com has insurance for this.

Alderman Silkaitis motioned to approve the CrowdStrike quote of \$33,825 and Chief Hansen seconded the motion.

The motion passed by roll call vote. (6 yea, 0 nay, 5 absent)
