There are also numerous issues with the building that need to be addressed: the awning needs to be built, more lights need to be installed, the front door needs to be replaced, there are also numerous odds and ends that need to be corrected. Brazos Contracting, who poured our driveway, has not been paid by the contractor. We are having trouble getting in touch with the contractor, he is not

returning calls or texts. He has moved to Mexia. Bob and Tad filled out and submitted a form to the contractor's bonding company today.

- A motion to approve contacting another contractor, if we do not hear from the general contractor by January 1st, was made by Bob Sthal, seconded by Jimmy Lehmann and the motion passed unanimously.
- FM 67 Covington as of last week, the roll-off dumpster was still on the property and full of trash. Tad will research how long we need to wait to consider it abandoned property.
- Abbott in the future the board would like to install a helipad at the location

9. Discuss with possible action the request from City of Abbott to share in sales tax revenue from business entities located within the area annexed by the City

- The contract drawn up by our attorney calls for sharing 75% of our 1% of the collected sales tax. The city would be paid their portion by us in March of every year.
- The city provided an agreement between the City of Montgomery and Montgomery ESD. This agreement shows the two sharing at 50%, but the comptroller handles sending the funds directly to the city. The City of Abbott is okay with signing the agreement from our attorney, but the commissioners agreed to table any decision until more research can be done.
