

# **CASE STUDIES**



Poor tax and regulatory compliance can abruptly stop your company's growth.

#### STARTUP PITFALLS (CONSTRUCTION)

The client is a startup construction company that phenomenally grew on its third year. Like most startups, the principal owners were more focused on operations and marketing. As financial transactions grew in volume, the company's accounting staff of two had weak financial controls and neglected reporting / regulatory compliance. On its fourth year, the company received LOAs from the BIR, employees complained that their SSS and Pag-Ibig contributions were not updated. This came as a surprise to the owners because they regularly signed the corresponding checks intended for that purpose. To make matters worse, the company found it difficult to renew its construction license with the Philippine Contractors Accreditation Board (PCAB) because of tax delinquencies.

DRJ Business Consulting consultants came in to assess the situation. They assisted the company in the BIR cases, updated the mandatory contributions and implemented financial controls to avoid a repeat of the said incidents. The consultants provided the accounting staff with tax compliance training and regularly monitored their performance.

#### KEEPING A TIGHT CONTROL WITH TECHNOLOGY (EXECUTIVE SEARCH FIRM)

The client is an Executive Search firm that recruits bilingual professionals for Japanese companies in the Philippines. The client asked us to help resolve issues such as BIR statutory compliance, proper interpretation of its monthly financial reports, intermingling of personal and business expenses of its managers and improper maintenance of its bookkeeping transactions. After careful consideration and study, we custom-tailored a solution where:

- A dedicated Finance Analyst monitors and prepares BIR compliance reports for timely submission.
- Management can view financial statements, worksheets and statutory reports 24/7 anytime of the day through an online portal.
- A procedure was implemented to streamline recording and identification of business-related expenses to avoid year-end tax filing issues.

Following a change management process, tax risks were eliminated and management now has tight control over its finances using real-time information to make quick business decisions.

#### STAYING ONE STEP AHEAD OF BIR EXAMINERS (GLOBAL EXHIBIT COMPANY)

A Singapore-based expo specialist, whose global presence is known for the design, creation and building of architectural interiors as well as experiential environments for events and exhibits, approached DRJ Business Consulting to handle its tax cases.
