### **Brief Biosketch:**

Michel D. Landry is a Professor in the Department of Health and Functioning, Section of Global Health, at the Western Norway University of Applied Sciences (HVL) in Bergen, Norway. Prior to HVL, he was the Chair of the Department of Physical Therapy and Associate Dean for Global Health, in the College of Health Professions, at Virginia Commonwealth University (VCU) in Richmond, Virginia. From 2011 to 2021, Dr. Landry spent several years as Professor and Division Chief of the Duke Doctor of Physical Therapy Division where he successfully led an important rebuilding of the program that has now grown into one of the top physical therapy programs in the United States. Prior to completing his doctoral and post-doctoral training, he held senior clinical management positions within the private rehabilitation sector in Ontario (Canada), and leadership positions within international humanitarian aid and development agencies in conflict and disaster settings. Dr. Landry is a health policy and health services researcher, a Past-President of the Canadian Physiotherapy Association, a former Career Scientist at the Ontario Ministry of Health and Long-Term Care (MOHLTC) and has been a consultant to many global multilateral agencies including the World Health Organization. Mike lectures widely on the public policy and political dynamics of rehabilitation, and is a provocative and disruptive advocate for the moral, ethical, and economic necessity to ensure rehabilitation services across the continuum of high, middle, and low-income countries.

### **Leadership Experience**

Across his 30-year career, Dr. Landry has held progressive leadership positions, including academic leadership, research & education, associations, and global health organizations.

Academic Leadership: Dr. Landry is currently the Chair of the Physical Therapy Department and the Associate Dean for Global Health at Virginia Commonwealth University (VCU). Prior to arriving at VCU, he spent a decade as Division Chief of the Duke Doctor of Physical Therapy (DPT) Division where he led an important rebuilding of the program. Since arriving in 2011, the DPT has repositioning its academic home, increasing its US News and Reports national rankings of physical therapy educational programs from #26 to #10, developed a large divisional federally funded research agenda, achieved the highest level of educational accreditation for the program. Dr. Landry has led several academic strategic planning processes and has been a member of number of editorial boards top peer- reviewed journals in his field.

Research & Education: Translation of rehabilitation health services research into practice and policy is a fundamental principal that drives Dr. Landry's research agenda. From the time Dr. Landry was initially funded by the Ontario Ministry of Health (equivalent to an NIH K-Award), most of his funded research and publications surround understanding rehabilitation supply and demand and developing health systems strengthening approaches to bridge the gap. His teaching and educational innovations have focused has been on global health, health system strengthening and rehabilitation health service and policy.

*Professional Associations:* Dr. Landry first became involved as a student representative to the Canadian Physiotherapy Association (CPA) in the 1990s. His CPA journey led to his appointment CPA President (2007-2009), where he implemented strategies to substantially grow membership, optimize financial stability through non-dues revenue generating activities, legislation around advances in scope of practice and specialization, and sophisticated national advocacy and lobbying strategies. He has remained a consultant to many PT organizations.

Global Health Organizations: Dr. Landry has been a rehabilitation leader in humanitarian aid organizations around the world for 25 years. For instance, following the 2015 earthquake in Nepal, he worked as policy consultant to the World Health Organization (WHO) field office in Kathmandu, and between 2016-2017, he consulted with the WHO in Geneva on guidelines development and minimal technical standards for rehabilitation interventions in disasters setting and in austere environments. He is guest editor for a special collection in BMC Health Services Research, titled Health services and systems in fragile and confpict-Oaffected regions.

### **Narratives: Global Health Experience**

I have been fortunate to contribute in many capacities across a variety of settings since beginning my global health career in 1996. Most of my clinical, educational or research experiences are based in complex sudden-onset disasters/emergencies and conflict/post conflict emergency settings. Below, I briefly highlight five of these engagements that were particularly impactful based on key performance indicators. Many of these experiences have been documented in my list of peer-reviewed publications.

### 2016-2018: Mali, Niger and Senegal

I was selected to be a mentor on a 2-year USAid-funded project called the "Strengthen the physiotherapy associations, Use the standards set by World Physiotherapy, Develop a paper on physiotherapy assistants' role, and Augment wheelchair training" or the (SUDA) project. Specifically, I was primarily a mentor for colleagues based in Mali where their goal was to scale up a fledgling professional association and improve their educational training program for physical therapists. At the completion of the project, the "Association des Kinesitherapeutes du Mali" was officially formed and was invited for membership in the world governing body called World Physiotherapy. On the other hand, the scaling for the training/education struggled to advance in unexpected ways. In global health management, research or practice, advancements or development is not always linear, and in the case of the SUDA project, our collective project team needed to re-evaluate the barriers. Ultimately, the educational outcomes were achieved, but not in the originally expected ways as we introduced digital health and education as a foundation.

### 2015-2017: Earthquake in Nepal, and WHO Headquarters

After the sudden-onset disasters in the Kathmandu Valley, I was invited by the World Health Organization (WHO) field office in Kathmandu for a 5-month rehabilitation/disability policy consultant. I travelled and lived in Kathmandu a few months after the earthquake and worked directly with the Ministry of Education and the Ministry of Health in Nepal to develop a comprehensive post-earthquake recovery plan that would place person with disability at the forefront of their build back better initiatives. In addition, I was also tasked with coordinating the disability-related NGO community who were on the ground to maximize outcomes and outputs in the immediate recovery phases. At the same time, I was also asked by the WHO headquarters in Geneva to also facilitate the development of the sub-documents within the "Minimal Technical Standards in Emergencies".

### 2010: Earthquake in Haiti

While I was a post-doctoral fellow at the Toronto Rehabilitation Institute (TRI), a massive earthquake occurred in Haiti in early 2010. The CEO of TRI asked me to conduct a rapid needs assessment of how to most effectively use the \$250,000.00 targeted donations that they received to mount an emergency response. I used my contacts in Haiti to first conduct a rapid needs assessment, develop an intervention plan, seek approval from TRI leadership and local partners, and then build a team of experts. The coordination of the response in Haiti was mostly chaotic due to the extensive damage, as a result I proposed to support a pre-existing NGO that has accepted 18 people who sustained spinal cord injuries from the event. The proposal was accepted by all parties, and I lead a multidisciplinary team of rehabilitation experts for 6-months in the northern part of the country.

### 2002-2009: Fawzia Sultan Healthcare Network - Kuwait

A Kuwaiti orthopedic surgeon colleague invited me to build a business plan to establish a non-profit rehabilitation-oriented clinic in Kuwait City. Over the period of 2002-2009, I worked with partners and funders based in the middle east to build what is now the Fawzia Sultan Healthcare Network (FSHN). While on the one hand, this may not appear to be tradition global health work, but on the other, health disparities in the Gulf are rather striking when comparing Kuwaiti national citizens, compared to other populations. Orienting the FSHN towards providing care for people excluded by the state-funded rehabilitation care was a significant goal and challenge. In the end, we implemented measures to ensure that all would receive care irrespective of their ability to pay, and FSHN remains a unique community-based experiment that has sustained the last 20 years.

## 1996-2000 Bosnia & Herzegovina, Kosova, and Guatemala

During the 4-year period between 1996-2000, I was the Project Manager for a War Victims Rehabilitation Project (WVRP) that was being implemented by the International Center for the Advancement of Community Based Rehabilitation at Queens University in Kingston, Canada. There were three primary locations of this federally-funded project and I divided my time between part of the Former Yugoslavia and Guatemala. The primary goal of the project was direct care delivery, and health systems strengthen through workforce development. At the end of project, I decided to begin my PhD studies.
