ORDINANCE NO. 2 - 2023

AN ORDINANCE OF THE TOWNSHIP OF SOUTH SHENANGO CRAWFORD COUNTY, PENNSYLVANIA, PROVIDING FOR THE DEFINITION AND ENFORCEMENT OF STANDARDS TO PREVENT NOISE POLLUTION WITHIN THE TOWNSHIP; PROVIDING FOR LIMITS FOR PERMISSIBLE SOUNDS LEVELS; PROHIBITING CERTAIN SOUNDS FROM BEING HEARD BEYOND PROPERTY LINES; PROVIDING FOR PENALTIES FOR VIOLATIONS; AND ESTABLISHING EXCEPTIONS AND THE BASIS FOR REQUESTING A VARIANCE FOR RELIEF FROM THE REQUIRMENTS OF THE ORDINANCE.
