John Novak, Little Fawn Acres, inquired on the mobile home in the allotment with no electric and water. They have been sent violations in the past and Bob will check to see if the Township can act on the violations though the court with what has already been done.

Roadmaster's Report – Jamie Fries

The road crew has been cleaning up leaves, started fall grading and getting ready for snow.

The supervisors asked Jamie if he had heard the status on the new truck that the Township is purchasing, and Jamie said he has not.

Attorney's Report – Brett Stedman

Mr. Stedman had a conference call with the Welcome Solar II applicants at 1:00 today. They are moving through the items that are required and they would like it to be considered by the Planning Commission next month.

A public hearing will need to be held for Walnut Creek Golf Course regarding intermunicipal transfer of a liquor license. Joe Livingston made a motion to hold the hearing November 14th at 2:30pm unless a court reporter is unavailable at that time. In the case that a court reporter in unavailable the hearing will be held November 14, 2023 at 6pm with a second by Nick Ceremuga. MC

Property Maintenance Official/Zoning Officer- Bob Goff

Many properties in violation were discussed and the supervisors advised Bob how to proceed. Bob also gave the supervisors a written report.

Supervisors' Report -

A conditional zoning permit and lot consolidation agreement was presented to the supervisors for Kenneth Santucci. Mr. Santucci applied for a zoning permit to construct an additional accessory structure on his property. Upon consideration of the application, the Township's zoning officer discovered that the existing house is being constructed across the boundary lines of multiple lots.

To rectify the matter, Owner agrees to undertake, the process of submitting a lot consolidation plan to the Township for its approval in accordance with Township Ordinance and State Law, and owner agrees such plan will be submitted in no more than (6) months. Joe Livingston made a motion to accept the agreement with a second by Mike Richer. MC

A grant opportunity was discussed, and Jamie was asked to apply for the grant.

Secretary's Report –Rebecca Andrew
