Decree of Validity and Apostolic Succession


I Reverend Monsignor Anselmo "Moy" P. Pamintuan, P.C., Founder and Priest Shepherd of the Benedictine Celestine of the Renewal. I finished my study in Philosophy and Theology degree from Saint Vincent Ferrer Seminary in Ilo-Ilo City in 1970 respectively. I was ordained to the sacred order of the Presbyterate at the age of 23 on March 30, 1974 by Most Rev. Gregorio Espiga, OAR. Vicar Apostolic Emeritus of Palawan. I took up Canon Law at the Pontifical University of Santo Tomas from 1983 up to 1985 and was bonafide member of CLSP (Canon Lawyer Society of the Philippines). Having lived in unity with the Roman Catholic Church and bring Canon law proper all my life. I carefully studied the Episcopal Lineage or Apostolic Succession of Archbishop Neville Anderson, Archbishop of Ballarat "Diocesan" Australia. Because some of my Priest/s Rev. Fr. Michael "Angel" Caadan, Rev. Fr. Emmanuel Ma. Jose Orminita, Rev. Fr. Jessie Mary Los Bañes, Rev. Fr. Joseph Camacho Ordained by Him in the Philippines when He was Arrived in NAIA Philippines for Pastoral Visit on 11th day October 2012.

As a Lawyer trained in Canon Law, Dogmatic Theology, Moral Theology and Ecclesiastical History I came to an absolute clear, and zero doubt conclusion that Archbishop Neville Anderson of Catholic Church of England & Wales Archbishop of Ballarat Australia as specifying in the following:


1. a Validly and Licit consecrated bishop.
2. not just any Christian bishop, but a traditional Roman Catholic bishop (Latin Rite).
3. a bishop consecrated in the pre-Vatican II form.
4. a bishop consecrated by a Roman Catholic bishop who himself was consecrated in the Pre-Vatican II form by a pre-Vatican II bishop.



As evidence by my identification card, seal and Celebret duly signed by Most Reverend Antonio Tobias D.D. Roman Catholic Bishop of Novaliches.




