# Goals and Objectives

#### Goal:

We are bringing back our lawful right to a Grand Jury for the purpose of holding the Liberal executive branch, and all Members of Parliament involved, accountable for breaking the law.

# What is Treason?

# Under the Criminal Code of Canada<sup>1</sup>, treason is defined as:

#### Section 46, Treason:

(2) Every one commits treason who, in Canada,

(a) uses force or violence for the purpose of overthrowing the government of Canada or a province;



### Treason

#### **Treasonous Acts in Canada:**

- 1. Chinese electoral interference
  - 1. Project Sidewinder 1995 2000<sup>1</sup>
    - A joint CSIS/RCMP investigation into Chinese electoral interference
    - Evidence was brough forward, and the project was killed in 2000
    - Most of the evidence was "inappropriately" destroyed
  - 2023 allegations of electoral interference was brought into the spotlight by a CSIS leak to the media
    - 2 MPPs resigned; Vincent Kay, PC and Han Dong, Liberal both of ON
    - Justin Trudeau appoints a Trudeau Foundation member and family friend David Johnston as "independent" special rapporteur looking into Chinese interference into our election.<sup>2</sup>
- 2. WEF infiltration
  - 1. Schwab stated over half of cabinet has been infiltrated by WEF "Global Young Leaders"
  - 2. Trudeau, Freeland, Blair, Mendicino, Lametti, Le Blanc, Singh and many MPs and Cabinet Ministers are members of the WEF
- 3. Illegal invocation of the Emergencies Act
  - Justice Mosley ruling on Jan 23, 2024, determined the EA was invoked unlawfully as it was *ultra vires* of the EA and was unconstitutional, violating section 8 of the Charter, the right to protection of unlawful search and seizure
    - 1. Grounds of a National emergency was not met
    - 2. Did not follow due process set out in the EA



# Introduction to Grand Jury

### **Grand Jury Introduction:**

- Grand juries were common at one point in Canada, and they are a measure of protection for the people against an out-of-control government.
- It is legal, lawful, and constitutional.
- Grand juries are outside of the common legal system, it's done by the people, and you don't need permission from anyone to do it.
- Grand juries are held against the state, not an individual.
- To bring the State before a State's judge would present a conflict of interest because State judges are normally paid by the State, and the same goes for criminal justice.
- Witnesses such as police are also often paid by the state. all of this would make it difficult to have a fair trial.



### Introduction to Grand Jury, Cont'd

### **Requirements to Holding a Grand Jury:**

- **1.** A Grand Jury constitution
  - an agreed upon set of rules and procedures on how the jury will be conducted
  - to include where, and when the hearing is, witnesses, list of those who will be summoned, defendants, Etc.
- 2. A "victim"/ "instigator"
  - Incident reports through sworn statement
  - Can also appear at the hearing and is a key witness who knows all about the case
- 3. Prosecutor to represent the "victim"
  - his/her job is to focus on organizing the grand jury and conduct the hearing
- 3. Other witnesses
- 4. A committee of the court, which is composed of 3 people:
  - Main prosecutor
  - President
  - Court secretary to record minutes, and organize paperwork



### Grand Jury Progress

### Work Completed to Date?

- Contacted the over 200 registrants to complete the Grand Jury selection process
  - 1. Completed the detailed questionnaire
  - 2. Conducted Zooms to identify and conduct screening to ensure the identity of registrants and qualifications
- 2. We have confirmed 18 participants in the Grand Jury
- **3.** Drafted the Grand Jury Constitution
  - 1. Provides the overview of the GJ
  - 2. Sets out the roles of the jurors
  - 3. Provides a guide/set of rules that we will follow
- 4. Developed the protocol for conducting the Grand Jury hearings
- 5. Updated the incident report and are continuing to finalize this report
