

Last July, then-White House Press Secretary Jen Psaki admitted that the White House was working with social media companies to identify "misinformation." Specifically, she said, "we're regularly making sure social media platforms are aware of the latest narratives, dangerous to public health that we and many other Americans are seeing across all of social and traditional media. And we work to engage with them to better understand the enforcement of social media platform policies."

AFL immediately submitted FOIA requests to the Department of Health and Human Services, the CDC, the Food and Drug Administration, and the National Institutes of Health to uncover the degree to which the CDC and the White House have been censoring content that it has deemed "disinformation" or "misinformation." Predictably, the Biden Administration obstructed and delayed complying with their legal obligation to provide such information, and AFL sued the CDC to compel their release.

Today, after a year of work, AFL has obtained its first damning release of documents. This is just the tip of the iceberg. In addition to the CDC working with the Census Bureau to "leverage their infrastructure to identify and monitor social media for vaccine misinformation," the 286 page production reveals shocking information, a sampling of which is below:

WASHINGTON, D.C. - Today, America First Legal (AFL) released the second set of shocking documents obtained from the Centers for Disease Control and Prevention (CDC) revealing further concrete evidence of collusion between the CDC and social media companies to censor free speech and silence the public square under the government's label of "misinformation."

AFL previously sued the CDC to compel the release of documents to uncover the degree to which the CDC and the White House had been censoring content it deemed "misinformation" or "disinformation."

After a year of work and demanding documents from Biden government bureaucrats, AFL has started to receive batches of documents.

This is AFL's second release of damning CDC documents. Our first release about collaboration between the CDC and Big Tech is here.

This production adds more evidence to what we now know happened: the Biden Administration and Big Tech companies colluded to throttle or outright censor speech






CDC "Vaccine Confidence Insights Report" Sent to Facebook and Google:

 On March 30, 2021 the CDC sent an email to Facebook and Google officials sharing a CDC "COVID-19 State of Vaccine Confidence Insights Report." Amongst the report's action items, the CDC includes short and long-term recommendations in order to "quickly and credibly debunk[ing] vaccine misinformation and disinformation."

Notably, the first long-term recommendation explicitly set forth the CDC's complicity with Big Tech to silence public conversation while "amplifying and promoting" content from "trustworthy sources, namely itself:

Long-term recommendations:

- Work with technology companies to slow the spread of misinformation while also amplifying and promoting credible, evidence-based information and trustworthy sources. Supported by research, use what is known about trusted sources of information to ensure audiences are receiving promotional content from sources they personally trust and already look to for credible advice and information.
- · Continue to partner with technology companies and researchers to better understand the interplay of digital media with vaccine confidence, including the consequences of exposure to misinformation, the pathways of misinformation and how it spreads within and across platforms, the role of influencers, and how misinformation impacts health-seeking behavior.
- Develop a network and community of practice for subject matter experts, federal partners, advocacy organizations, institutions of higher education, and states and jurisdictions focused on addressing the COVID-19 infodemic and future health infodemics in the United States.



AFL continues to vigilantly monitor the federal government and conduct crucial oversight work to ensure the American public knows the harsh realities of the government's undermining of the rule of law.





Claims about the **existence or severity of COVID-19**. Acknowledging the existence and understanding the severity of COVID-19 is foundational to keeping people safe and aware of the dangers of this public health emergency. We remove claims that deny the existence of the disease or undermine the severity of COVID-19. This includes:

- Claims that COVID-19 is no more dangerous to people than the common flu or cold.
- Facebook uses incredibly vague and nebulous standards to judge information (pg. 50).

False Claims about Covid Vaccines

- Claims about the availability or existence of COVID-19 vaccines
- Claims about the safety or serious side effects of COVID-19 vaccines
- Claims about the efficacy of COVID-19 vaccines
- Claims about how the COVID-19 vaccine was developed or its ingredients
- Claims involving conspiracy theories about a COVID-19 vaccine or vaccination program
- In its "Widely Debunked Vaccine Hoaxes" section, Facebook even claims that "natural immunity is safer than vaccine acquired immunity" despite 1) widespread



For the duration of the COVID public health emergency, we remove content that repeats other false health information, primarily about vaccines, that are widely debunked by leading health organizations such as the World Health Organization (WHO) and the Centers for Disease Control and Prevention (CDC). The goal of this policy is to combat misinformation about vaccinations and diseases, which if believed could result in reduced vaccinations and harm public health and safety.

- Vaccines cause autism
- Vaccines cause Sudden Infant Death Syndrome
- Vaccines cause the disease against which they are meant to protect, or cause the person to be more likely to get the disease
- Vaccines or their ingredients are deadly, toxic, poisonous, harmful, or dangerous
- Natural immunity is safer than vaccine acquired immunity
- It is dangerous to get several vaccines in a short period of time, even if that timing is medically recommended
- Vaccines are not effective to prevent the disease against which they purport to protect
- Acquiring measles cannot cause death (requires additional information and/or context)
- Vitamin C is as effective as vaccines in preventing diseases for which vaccines exist.
- Finally, Facebook boasts of removing over 16 Million posts on Facebook and Instagram, including over 2 million between February and May 19, 2021. (pg. 53):

Since the pandemic began, we've removed more than **16 million pieces of content** on Facebook and Instagram for violating our COVID-19 and vaccine policies.

This includes **more 2 million** pieces of content removed since February alone, when we expanded our COVID and vaccine misinformation policies.





WASHINGTON, D.C. – Today, America First Legal (AFL) released the **fourth set** of shocking documents obtained from litigation against the Centers for Disease Control and Prevention (CDC) revealing further concrete evidence of collusion between the CDC and social media companies to censor free speech and silence the public square under the government's label of "misinformation."



This production also reveals that the U.S. government was actively working to "socially inoculate"—or brainwashing—the public against anything that threatened its narrative. It did so by using aligned Big Tech corporations to monitor and manipulate users for the purposes of censoring unapproved information and pushing government propaganda. For example, Facebook sent written materials to the CDC in which it bragged about censoring more than *sixteen million* "pieces of content" containing opinions or information the U.S. government wanted suppressed.


Finally, the documents reveal the CDC was "collaborating with UNICEF, WHO and IFCN member and leading civil society organization Mafindo" to mitigate "disinformation." Mafindo is a Facebook third-party fact-checking partner based in Indonesia that is funded by Google.

What is clear is that the United States government, Big Tech platforms, and international organizations were fully entangled in an intricate campaign to violate the First Amendment, to silence the American people, and to censor dissenting views.

AFL's first release of documents revealed the explicit collusion between the CDC and Big Tech to censor what the Biden Administration deemed "misinformation" and push covert COVID-19 propaganda. AFL's second release built the evidentiary record showing that CDC specifically sent Facebook and Twitter-specific posts to take down, throttle, censor, or flag. AFL's third release revealed that the CDC's mask guidance policies for school children were driven by political polling by liberal dark money group The Kaiser Family Foundation rather than science.


