Executive summary

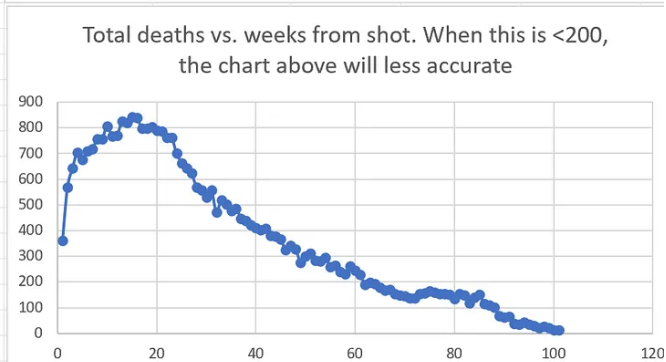
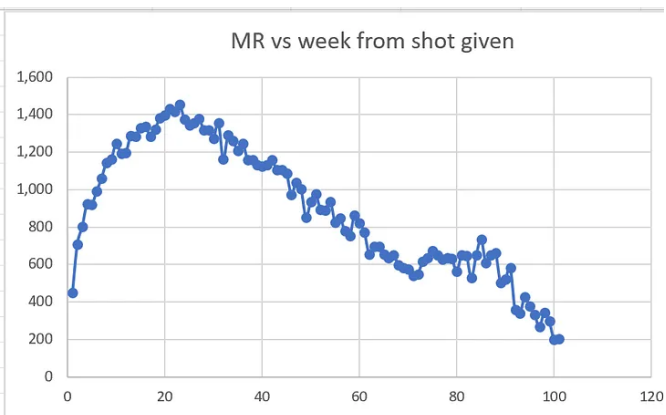
See the [slide deck](#), slides 85 and 86 for what they said. They basically said that this data removes all doubt about the vaccines killing massive numbers of people.
