MOTION BY CLOUS SUPPORTED BY BURROUGHS TO ADD TERRORISM COVERAGE IN THE INSURANCE PACKAGE. ALL IN FAVOR; MOTION CARRIED.

MOTION BY CLOUS SUPPORTED BY BURROUGHS TO RENEW THE INSURANCE POLICY WITH PETERSON MCGREGOR. ALL IN FAVOR; MOTION CARRIED.

MOTION BY SURROUGHS SUPPORTED BY CARLSEN TO ACCEPT THE BILLS AS READ BUT NOT PAYING THE GUTHRIE AND HELSEL BILLINGS. ALL IN FAVOR; MOTION CARRIED.

HEYMES SUBMITTED A QUOTE FOR CHEMICAL TREATMENT, THE COUNCIL WILL REVISIT THE COSTS AGAIN IN MAY.

GABIER ASKED ABOUT A TAX ABATEMENT FOR HIS PROPERTY IF HE PUT IN HIS OWN WELLS. HOWELL IS INVESTIGATING THIS QUESTION WITH THE MICHIGAN MUNICIPAL LEAGUE AND ATTORNEY.

CLOUS GAVE AN UPDATE ON THE CULVERT PROJECT.

THE COUNCIL WILL REVIEW PERSONS NOT HOOKED UP TO SEWER IN MAY, AFTER READING THE SEWER ORDINANCE.
