MOTION BY BURROUGHS SUPPORTED BY CLOUS TO ACCEPT THE MINUTES AS READ. WITH ONE CORRECTION OF A MOTION. ALL IN FAVOR; MOTION CARRIED.

MOTION BY CARLSEN SUPPORTED BY BURROUGHS TO ACCEPT THE BILLS AS READ. ALL IN FAVOR; MOTION CARRIED.

MOTION BY SMITH SUPPORTED BY CLOUS TO KEEP THE MILLAGE AT .11. ALL IN FAVOR; MOTION CARRIED.

MOTION BY CLOUS SUPPORTED BY CARLSEN TO USE THE WATER RATE INCREASE OF COMODITY AND METER BEING \$1.50 PER 1000 GALLONS AND \$20.58 METER RATE CHARGE PER MONTH. ALL IN FAVOR; MOTION CARRIED.

MOTION BY CLOUS SUPPORTED BY BESAW NOT TO PURCHASE THE FORECLOSED PROPERTIES OFFERED BY WEXFORD COUNTY. ALL IN FAVOR; MOTION CARRIED.

MOTION BY BURROUGHS SUPPORTED BY CARLSEN TO ALLOW THE VILLAGE ATTORNEY TO REFILE NONCOMPLIANCE OF BLIGHT ORDINANCE AGAINST VANNATTERS. ALL IN FAVOR; MOTION CARRIED.

STANTON WILL SEND BLIGHT LETTERS TO FULLERS AND JORIAS.

STANTON WILL LOOK INTO A FOOD TRUCK ORDINANCE.

HEYMES INDICATED THAT THE SEWER PIPES NEED CLEANING AND SHOULD BE PUT INTO A BUDGET. THE SAMPSON HOME DOES NOT HAVE SEWER. HEYMES USED DYE AND WATER TO CHECK FOR A CONNECTION.

CLOUS IS STILL WAITING FOR BOB CARPENTERS BID TO REMOVE THE PILES.

CLOUS WILL CONTACT GABIER TO ANSWER WHY THE VILLAGE DOES NOT PLOW UP THE HILL. SIMMONS STREET BY THE ACT 51 STREET MAP IS ONLY AT THE BASE OF THE HILL.

BURROUGHS INDICATED THAT THEIR WERE TIRES LEFT AT THE BRUSH PILE AND TO HAVE ABEL MAKE A SIGN "NO DUMPING OF GARBAGE" ONLY LEAVES, BRUSH, AND YARD WASTE.
