REAM THANKED HEYMES FOR ALL THE WORK HE HAS DONE AT THE NEW COMMUNITY CENTER/LIBRARY. SHE ANNOUNCED THAT THE GRAND OPENING FOR THE NEW COMMUNITY CENTER/LIBRARY WILL BE NOVEMBER 9TH, 2019.
