

Failure to comply with these instructions may result in the cancellation of your procedure. Arrange for a ride home from a licensed driver after your procedure. Don't take a bus, cab, or ridesharing service unless an adult rides with you.

ONE WEEK PRIOR TO PROCEDURE:

- Discontinue taking: Vitamin E, Ginkgo, Omega 3, Fish oil, Flax seed, Ginseng, & NSAIDs (Ibuprofen, Motrin, Advil, Excedrin, Aleve). You may take Tylenol for aches or pain if necessary. ONLY if you have heart disease, you may continue your daily Aspirin.
- If taking Coumadin, Eliquis, Plavix, Pradaxa, or Xarelto, please do NOT discontinue these medications without proper authorization from our office.
- Continue taking all other prescribed medications including heart and blood pressure medications.

TWO DAYS PRIOR TO PROCEDURE

• Do <u>NOT</u> eat any seeded foods (seeded fruits, seeded breads, nuts, popcorn, or corn).

ONE DAY PRIOR TO PROCEDURE:

• **NO SOLID FOOD.** Clear liquid diet for breakfast, lunch, and dinner.

DO's	DON'TS
Apple Juice, Clear Soda,	SOLID FOOD
Beef, Chicken or Vegetable Broth (Liquid Only)	Apple Sauce, Eggs, Soup, Oatmeal,
Coconut Water (No Shavings),	Orange, Grapefruit, or Pineapple Juice,
Black Coffee, or Tea (No Cream),	Milk or Dairy Products,
Jell-O or Gatorade (No Red or Purple).	Malt, Alcoholic Drinks.

- At 6 PM mix a bottle of SUPREP with water up to the 16oz line on the plastic cup, then drink the entire solution followed by two (2) more 16oz of water within 1 hr. You may continue a clear liquid diet.
- At Midnight repeat with the other bottle of SUPREP, then drink the entire solution followed by two more 16oz of water within 1 hr. <u>DO NOT DRINK OR EAT ANYTHING ELSE AFTER</u>.

ON THE DAY OF THE PROCEDURE:

- DO NOT DRINK OR EAT ANYTHING.
- Please take all heart or blood pressure medications with a small sip of water.
- Do not take diabetic medication the morning of your procedure.
- Please bring all your medications with you to the facility.
