Moving Forward

So here we are, just around the corner from the majority of Ohio's Covid restrictions being lifted. What now? Just like many of you, that is what we are working on figuring out as we transition (over the next many weeks) as much as possible back to the "old



days". At the same time we have been so blessed these past 14 months, having had only one known youth Covid case and a handful of employee Covid cases. While staffing and scheduling have been difficult at times in order to best negotiate our Covid challenges, we did it. We did it because our staff soldiered through to come to work and care for our kids while many themselves were dealing with their own Covid situations involving their family members and others close to them.

While we are glad that Ohio is in a place where nearly all restrictions will end on June 2nd, we will not be returning to our pre-Covid days overnight. We will transition over the next several weeks to get back to "normal". This means examining and reintroducing pre-Covid services back to our youth, which involves looking at internal matters as well as external. Some of these include a cautious approach to permitting volunteers, contract service providers, probation staff, counselors, therapy dogs, and others to begin coming back into our building to help our kids. Of course we wish Covid had never existed but at the same time consider it a privilege to have been able to serve and lead during all that this virus has brought us. Onward!






