### Art Experience 2020 is Here!!!

The auction will run through **next Thursday (Oct. 1st) until 7:00pm** when all of the bidding will be final. There are 15 Mandala Tiles up for *sponsorship* that were created under the direction of the Akron Bomb Brigade (<a href="https://www.akronartbomb.com">www.akronartbomb.com</a>). They will all be displayed together in one large mural at the Medina County Juvenile Court. If you choose to sponsor any of them, you will have the name you choose (personal or business/organization) engraved on a plaque next to the mural. All of the proceeds go directly to the continuation of our Therapeutic Art program!

Those who sponsor a Mandala Tile will receive a complimentary pack of 10 blank greeting cards. Additional cards will be available during pickup times for sale. Of our pieces donated, The Children's Center returns 50% of those proceeds back to the detention center for continued therapeutic art while retaining 50% for the needs of the kids they serve. This is my temporary home, It's a drug free zone. I reside in cell 146, the one with light brown bricks.

My toilet and sink are connected, and it always gets inspected. Once a day I go to gym, I move around this place like a Sim.

Twice a week I get to see Mrs. Jarvis, and her lessons are always marvelous. I get cake at eight every night, and I smile with every bite.

During the school day Mrs. Chasar helps me with math, and when someone makes her mad we hear her wrath.

I enjoy my talks with Mr. Stollar, even though when he sees me in here he wants to holler.

I've been coming here since I was fourteen, and I know the whole week's routine.

Even though I complain every day, at least I don't want to run away.

Soon I will age out of here, and I will probably shed a tear. I know these people better than my own family, and being here makes me somewhat happy.

My temporary home is called MCJDC, and it will always be a part of me!

## **Medina Light Ministries**

Medina Light Ministries is a non-denominational, faith-based ministry, run by Larry and Sue Jarvis who have been serving our kids since we opened in 1999. (Sue is the person referenced in the above poem and the pic below.) Here are some words from her:

"I am still Skyping with the teens on Thursdays and Sundays. We have worked really hard on a few themes in the past couple of months.

Evolution vs creation How the Bible was put together Why bad things happen What does it mean to be saved?

We did a series we called, 'Who Are You?' . It dealt with the fact that you are created by God for a purpose. He loves you and you are valuable in every way to Him. We spent time discussing the five myths by which people in the world define themselves:

I am what I do
I am what I feel
I am what I have
I am what others say I am
I am what has happened to me

Please pray that the teens 'heard' these lessons!"

Note that all faith-based services are optional for our kids. A big THANK YOU to Medina Light Ministries for all their years of *volunteer* service to our kids!!




