Throughout his years of addiction he found himself in trouble and struggled to maintain relationships, however, he ultimately found a way to overcome it all and turn his life around! He and Jenna are married with a beautiful daughter, Penelope, and they donated an entire afternoon to speak

to the kids. Jenna understands addiction from a partner's perspective as well as being a child of a parent who suffers from addiction. The multiple perspectives of the couple helped to reach every child who heard Ryan's intensive, passionate, and warming speech. He shared his story about who he was as a young adolescent, who he spent time with and how that influenced his choices, his lack of ability at first to stay clean, and how he came upon the motivation to make major life changes which allows him to be a good husband and father to this day. Ryan and Jenna spent time in each unit with the kids in smaller groups so they could have a more personal conversation, asking the questions they wanted to, and receiving more individualized feedback. ## **Leadership Medina County Visit**

Recently, we had the opportunity to host the Leadership Medina Counties Legacy Leaders, Signature and Emerging Leader programs at our facility as part of their Local Government Day. During their visit, they received a tour of the facility and had the opportunity to hear from Superintendent Ron Stollar, Judge Kevin Dunn, and Assistant Superintendent Megan Millikin. Mr. Stollar spoke about the different types of services we provide such as, art class, music therapy, animal therapy, life skills and many more. We explained a cultural change we made in 2015, as a facility, to reinforce positive behavior through our behavioral level system. We all shared multiple stories about our experiences at the detention center and answered many questions. Here are a few thoughts from the group about their experience:

"I am so impressed with how many programs are available through the court, jail and juvenile detention center."

"I was encouraged to learn that our county's philosophy trends more toward healing and reintegration, especially on the juvenile level. As an individual in charge of staffing my facility, I believe I will possibly consider more 2nd chance options."

"It's difficult to hear about everything that's going on in the county and all of the needs that there are to face, as well as all of the positive projects and not want to get involved in some manner. Personally, with my background in social work and also working with teenagers from the juvenile court system in Cuyahoga County, it was a reminder of what it's like to be in the position of caring for these kids on a day-to-day basis."

There were countless observations made by the group about their visit to our facility. We enjoy spending time with groups such as, Leadership Medina County. It allows us an




