## ATTENDEE EVENT RULES AND REGULATIONS

### 1. EVENT ENTRY HOURS

A. Event / Show hours are 7am - 5pm Friday Sept 6th & 8am - 5pm Saturday Sept 7th. Participant parking is first come, first served. No participant vehicles will be driven on vendor midway during show hours.

B. Handicapped parking is available on site.

### 3. INSURANCE, REGISTRATION & VALID DRIVERS LICENSE REQUIRED

### 4. OPERATIONS AND CONDUCT AT EVENT

A. TCR LLC reserves the right to remove any attendee deemed not family/show friendly by TCR LLC staff. All decisions are at the sole discretion of TCR LLC and are final. Vulgar language, alcoholic beverage consumption or drug use will not be tolerated at event site.

B. No grilling/cooking allowed on event grounds. No glass bottles.

C. None of the following items [guns, knives, drug paraphernalia, animals, reptiles, birds, or any illegal substance or items] are permitted, or used in any part of the event space or grounds. Single occupancy (ADA approved) scooter or service animal will only be allowed for use by handicapped personnel.

D. No dogs or pets are allowed.

E. Attendees must wear appropriate apparel (i.e. no swimwear, thong shorts, or bikinis). No vulgar or unlawful products and/or services (as determined at the sole discretion of TCR LLC) shall be sold, promoted or demonstrated at the event.

F. Attendee is responsible for all damage to any property caused by attendee or associates of attendee.

G. Attendees shall not distribute any advertising matter, literature, souvenir items or promotional materials. Sale of any goods is strictly prohibited.

H. Trailer Parking: Attendees with trailers or oversized vehicles are required to park in the designated area marked as "Trailer" parking. This is a free parking area. Tow rigs and trailers will be able to enter the grounds Thursday September 5th from 8am-5pm, Friday September 6th from 7am-5pm and Saturday September 7th from 7am - 12pm noon. Vehicles will not be able to enter the show grounds until gates open Friday September 6th at 7am and Saturday September 7th 8am.

I. RV Parking is PRE-REGISTRATION ONLY. There are no hook-ups or facilities available for RV's. There are no in/out privileges for RV parking. RV parking is \$75 and is PRE-REGISTRATION ONLY.

J. Show vehicles can remain inside event over night. The Speedway will be secured at 6pm each day. TCR LLC, Nashville Superspeedway or any of their associates will not be responsible or liable for any theft or damage to vehicles left on the event grounds or inside the event space over night.

K. If a Display Vehicle used in an outdoor vendor exhibit is to have "in and out" event driving privileges, it must be registered as a normal participant vehicle for the event.

L. Portable shade canopies are allowed but must be secured and owner is solely responsible for any damage caused by them.

M. Attendees MUST keep the noise levels from music or stereos to a minimum and must never interfere with TCR LLC or the facility public announcement systems.

N. NO voice amplification.

O. All tow rigs trailers and RVs must be removed from event grounds by Sunday September 8 at 12pm

I acknowledge that this Release of Liability will be used by the event holders, sponsors, and organizers of the event in which I may participate, and that it will govern my actions and responsibilities at said event.
