



New Track & Promoter Information

Thank you for your interest in getting involved in our organization! These are some **preliminary requirements** for holding/promoting a race. This is **not** a complete list, but some of the most significant requirements and considerations. Once the board has received and reviewed this information, a representative from the NYOA Board will contact the promoter.

Land Requirements

250-400+ acres depending on topography

Parking/Camping/Vendors/Registration/Start Area

25-40+ acres that are useable for parking/camping. This may vary depending on the land's topography.

Vendors and Registration area: Usually 1-2 acres typically adjacent to the parking and/or camping fields

Enough property to have an 8.5-12 mile Adult track and 4-6 mile Mini track (Adult and mini may share parts of the same course). Must also have enough property for a **separate** 1.5-2 mile Pee Wee track. Estimates again depending on topography range from 250-400+ acres

Unless the interested party is the land owner, any new promoter(s)/club must have a written commitment from the land owner. This document should be provided with interest form if possible.

Preferred locations will be within a 100 miles of Tioga County

Entrance and Exit from Property

Must have designated entrance **and** exit that can be used simultaneously. Minimum width of EACH lane 10 feet, or, if single entry it must be a minimum of 20 feet wide.

Both **MUST** be passable in a safe manner even with inclement weather before or during the event.

Must have or have machine(s) available on race weekend capable of towing in and out 40,000lbs+ motorhome/toter-homes with trailers

Pre-Race Estimated Expenses

Must have \$10,000- \$15,000 liquid cash for pre-race expenses.

Pre-Race and Race Weekend Details

Must have and inform NYOA of how promoter(s) plan to have/get a **minimum** of 30 workers for their event.

Promoter must be able to allocate/dedicate 100-200hr of pre-race prep track building, organizing vendors, permits, insurance, port-a-potty's etc.

It is preferable that Promoter live within 1 hour of the proposed race location, or show a detailed dated plan of how site, track and race event preparation will be completed.
