Fences

- (a) All fences must receive prior written approval by the Architectural Control Committee and shall comply with any requirements set out below. Zoning approval and/or building permit from the City of Madison Wisconsin may be required to construct fencing. ACC approval does not supersede the need for any municipal approvals or permits.
- (b) Chain link fences are not allowed.
- (c) Fencing four (4) feet in height and lower is permitted. It should match the aesthetic design of the home. No fence over four (4) feet shall be erected on any part of any lot except when required by Madison Wisconsin City Ordinance.
- (d) Fences must be constructed of materials such as wood, ornamental metal, vinyl, brick or stone. Fence design and materials chosen should complement the house.
- (e) Orientation. The most aesthetically pleasing side of the Fence must face the neighboring properties. Structural elements such as posts, rails, channels and lesser details shall face the Owners Lot.

It is agreed and understood that Lot Owner and Landscaper have read and understand the recorded Restrictions and Covenants including, but not limited to, landscaping requirements.

By approval of the plans submitted to the Architectural Control Committee, Lot Owner and Landscaper shall be responsible for obtaining any approval necessitated by City or Village ordinances, and the Architectural Control Committee gives any opinion nor makes any representation as to soil conditions or that the plans or site plan meet any city, county, or state codes or ordinances. Neither the Lot Owner nor the Architectural Control Committee shall have any liability to any landscaper or lot owner with respect to the construction of landscaping/exterior additions on a lot within the plat. It shall be the Landscaper and lot owner's sole responsibility to obtain all permits for the construction of any improvements on a lot in the plat.
