## **Annual Meeting: 5:08 PM**

- Call to order and roll call: Present: Martha Bayona, Joanna Fuentes, Stacie Johnson, Maria Lopez, Wanda Nunez, Desines Rodriguez, Renesha Westbrooks. Absent: Samuel Olivares. Late: Wanda Nunez.
- 2. Selection of Chair *Pro Tem* to preside during the CEC32 Officer Elections
  - a. Member Desines Rodriguez nominated herself. Member Desines Rodriguez was unanimously selected to preside as Chair *Pro Tem* and run the nomination and election of the CEC32 President.
  - b. Member Desines Rodriguez stepped down from the Chair *Pro Tem* position at the time of the Vice-President election to nominate herself. In her stead, Member Maria Lopez nominated herself to be the Chair Pro Tem. Members Martha Bayona, Stacie Johnson, Maria Lopez, Wanda Nunez, Desines Rodriguez, and Renesha Westbrooks selected Member Maria Lopez to preside as Chair Pro Tem and run the nomination and election of the CEC32 Vice-President and Recording Secretary.
  - c. Member Maria Lopez stepped down from the Chair *Pro Tem* position at the time of the Treasurer election to accept a nomination to run for this Office. Member Desines Rodriguez nominated herself to be the Chair *Pro Tem*. Respectively, each candidate received 5/2 votes. Martha Bayona continues to be the elected President of the CEC32.
