RESOLUTION 2022-10 AMERICAN RESCUE PLAN FOR 2021 BUDGET

Rick Green motioned to approve Resolution 2022-10 for the supplemental appropriation of American Rescue Plan Allocation of \$243,722.26 for the 2021 Budget. The funds will be disbursed upon the implementation of the final rule. Larry Osche seconded the motion. Motion Carried Unanimously.

RESOLUTION 2022-11 AMERICAN RESCUE PLAN FOR 2022 BUDGET

The final rule of the American Rescue Plan was implemented on April 1, 2022. Rick Green motioned to approve Resolution 2022-11 for the 2021 supplemental appropriation of American Rescue Plan Allocation of \$243,722.26 for the 2022 Budget for government services revenue loss. Larry Osche seconded the motion. Motion Carried Unanimously.

HEADLAND ROAD

Larry Osche motioned to advertise for bid the mill and fill of Headland Road. Rick Green seconded the motion. Motion Carried Unanimously.

ROADMASTER REPORT

The Roadmaster presented the following report.

- 1. Traffic control for the tree trimming project was conducted.
- 2. Brushing of roads to remove anti-skid was performed.
- 3. Vehicle maintenance was performed.

ADDITIONAL BUSINESS

Phillip Bauldoff applied for the volunteer fire company earned income tax credit. The Township Secretary verified that Mr. Bauldoff is on the Herman Volunteer Fire Company eligibility list. Rick Green motioned to approve Phillip Bauldoff for the Herman Volunteer Fire Company earned income tax credit. Larry Osche seconded the motion. Motion Carried Unanimously.

Shields Asphalt Paving, Inc. was sent a certified letter stating the Township will not accept bids from the company until the Bonniebrook Road cracking pavement is resolved.
