Willie Adams motioned to approve Resolution 2021-11 the 3-year plan for the CDBG grant to designate the funding for the mandatory public sewage tap-in fee for low-moderate income residents. Rick Green seconded the motion. Motion Carried Unanimously.

CDBG 3-YEAR PLAN

Willie Adams motioned to approve the CDBG 3-year grant plan to designate the funds for the mandatory public sewage tap-in fee for low-moderate income residents. Rick Green seconded the motion. Motion Carried Unanimously.

RESOLUTION 12 FAIR HOUSING

Willie Adams motioned to approve Resolution 2021-12 for fair housing. Rick Green seconded the motion. Motion Carried Unanimously.

CD RENEWAL

Willie Adams motioned to renew the General Fund CD for 3-months with NexTier Bank. Rick Green seconded the motion. Motion Carried Unanimously.

DRIVEWAYS

A driveway at 315 Bonniebrook Road has a drop-off and water issue. The Supervisors will look at the driveway.

NIGHT LIGHT AT ROUTE 422 & ROUTE 68 INTERSECTION

On August 1, 2021 the State Police reported to Larry Osche, Roadmaster, that the night light pole and base at Route 422 and Route 68 intersection was broken due to an accident

Larry Osche contacted Bronder Technical Services for a quote for the base and night light. Rick Green motioned to authorize Larry Osche to purchase a new base and night light for the Route 422 and Route 68 intersection. Willie Adams seconded the motion. Motion Carried Unanimously.

A reimbursement invoice for the night light and base will be submitted to the insurance company that is responsible for the accident damages.

BUILDING AWNINGS

Willie Adams motioned to approve the purchase awnings for the Township building and front door outside light. Rick Green seconded the motion. Motion Carried Unanimously.

BONNIEBROOK ROAD

Larry Osche motioned to approve for payment Shields Asphalt Paving, Inc. application number 2 for the paving of Bonniebrook Road Multimodal Transportation Fund Grant project for \$662,219.92 contingent upon receiving Jefferson Township's portion of the invoice. Rick Green seconded the motion. Motion Carried Unanimously.

Summit Township and Jefferson Township will be reimbursed a portion of the invoice through the Multimodal Transportation Fund Grant.

KEMAR DRIVE

Rick Green motioned for additional pavement for Kemar Drive. Willie Adams seconded the motion. Motion Carried Unanimously.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Kemar Drive project.
- 2. The shoulder work on Bonniebrook Road has been completed.
- 3. Butler County Commissioner Kim Geyer contacted Larry Osche regarding the Geibel Road bridge repair. The Southwest Regional Commission took pictures and completed a traffic study for the bridge. The report is to be submitted to the Township but has not been received. An email will be sent to the County requesting the report.
- 4. Philmar Drive has an issue with vehicles parking on the road. This will be discussed with the Solicitor at the next public meeting.
- 5. The seal coat project has been completed.

ADDITIONAL BUSINESS

Rick Green is going to research if the Saxonburg Police can patrol state roads.

Willie Adams announced an executive session was held before the public meeting at 6:15 p.m. on August 4, 2021 regarding pending litigation. No decisions were made.
