Larry Osche motioned to approve for payment M & M Lime Company, Inc. invoice 9604 for Stutz Road rip rap for \$557.97. Willie Adams seconded the motion. Motion Carried Unanimously.

Willie Adams motioned to approve for payment the 9<sup>th</sup> installment payment for the volunteer fire companies worker's compensation policy for \$1,076.00. Larry Osche seconded the motion. Motion Carried Unanimously.

Larry Osche motioned to approve for payment Youngblood Paving, Inc. invoice 2021-1340 for the seal coat project for \$57,106.80. Willie Adams seconded the motion. Motion Carried Unanimously.

#### **SUMMIT AUTHORITY PAYMENT REQUEST**

Larry Osche motioned to approve for payment Summit Authority's payment request for the following invoices for a total of \$3,199.00. The Authority will reimburse the Township upon receiving funding.

Gallagher Law Group invoice 964 for the Rails-to-Trails Agreement for \$36.00. Jerich Insurance Agency invoice 2556 for the Authority's liability insurance for \$3,163.00.

Willie Adams seconded the motion. Motion Carried Unanimously.

#### **SOLICITOR REPORT**

The Supervisors held with the Solicitor an executive session before the public to discuss employee issues and current litigation.

The Township can access a right-of-way easement by imminent domain. The Solicitor suggested utilizing James Keffalas as a realtor for this. He has extensive experience in this matter.

#### **GEIBEL ROAD BRIDGE**

The Township is very dissatisfied with the Southwestern PA Commission suggestions in a technical memorandum for the Geibel Road bridge repair. The Township will seek a meeting with State Representative Marci Mustello.

#### **ENGINEER REPORT**

No activity to report.

## **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following report:

- 1. Cleaning catch basins, brush, and trees due to the recent heavy rains.
- 2. Roads were vacuumed from the seal coat project.
- 3. Bonniebrook Road shoulders are to be shot with MC-70 before the white lines are painted.
- 4. Shields Paving, Inc. has made repairs that were outstanding from the Bonniebrook Road project.

#### **ADDITIONAL BUSINESS**

Ryan Harr from Butler County Conservation District said additional funding may be available to pave the cross-pipe area on Stutz Road.

Brinker Road has a sink hole that has appeared. It must be dug out, filled and repaved.

The underground powerlines for the traffic lights at Route 38, Route 68 and Route 422 need located for the bridge project.

Philmar Drive has a resident/tenant that parked a car on the road that prevented road work. The resident/tenant did move the vehicle. Chief Beachem of the Saxonburg Police Department will be contacted regarding the policy to tow a vehicle in the absence of "no parking" signs.

The Saxonburg Police are allowed to patrol state highways, just not interstate highways.

Willie Adams announced executive sessions were held on the following dates:

August 4, 2021 the Supervisors met with the Township Emergency Management Coordinator and Lick Hill Volunteer Fire Department. No decisions were made.

August 9, 2021 the Supervisors looked at driveway situations. No decisions were made.

August 18, 2021 the Supervisors met with the Township Emergency Management Coordinator and Lick Hill Volunteer Fire Department. No decisions were made.

The 2009 Peterbilt truck is down for the repair with at the least a water pump issue.

# **OPEN TO THE FLOOR – PUBLIC PARTICIPATION**

A resident stated concerns about the intersection of Simon Drive and Herman Road with drivers cutting the corner from Herman Road onto Simon Drive. The trees need trimmed, and centerlines painted.
