# APPROVAL OF THE NOVEMBER 20, 2019 PUBLIC MEETING MINUTES

Rick Green motioned to approve the November 20, 2019 public as presented. Willie Adams seconded the motion. Motion Carried Unanimously.

# 2019-14 RESOLUTION FOR 2020 BUDGET

Rick Green motioned to approve Resolution 2019-14 for the 2020 General Fund, Capital Fund, Fire Hydrant Fund, Sewage Escrow Fund, Sewage Permit Fund and State Fund budgets. Willie Adams seconded the motion. Rick Green voted "yes". Willie Adams voted "no.". Motion did not carry.

Resolution 2019-14 for the approval of the 2020 budgets will be presented the next meeting.

## **CAPITAL FUND CD RENEWAL**

Rick Green motioned to approve the renewal of the Capital Fund CD for 3 months with NexTier Bank. Willie Adams seconded the motion. Motion Carried Unanimously.

## **EARNED INCOME TAX CREDIT**

Herman Volunteer Fire Company submitted their list of members that qualify for the Earned Income Tax Credit. The Township Secretary/Treasurer notarized the list. The Township Secretary/Treasurer verified the individual that submitted the Earned Income Tax Credit request was eligible.

Willie Adams motioned to approve for the individual to receive the Earned Income Tax Credit. Rick Green seconded the motion. Motion Carried Unanimously.

#### **BCATO MEMBERSHIP**

Willie Adams motioned to approve the Butler County Township Officials (BCATO) membership for 2020. Rick Green seconded the motion. Motion Carried Unanimously.

#### **PTO MEETING**

Willie Adams motioned for the Summit Elementary School Parent Teacher Organization (PTO) to hold their meeting the second Wednesday of the month at 6:30 p.m. as long as the meeting does not interfere with Township business. Rick Green seconded the motion. Motion Carried Unanimously.

# **ROADMASTER REPORT**

Roadmaster, Larry Osche, was absent. The Secretary/Treasurer presented the Roadmaster Report:

- 1. Drainage on Valley View Drive is completed.
- 2. Cutting back of brush on roads was performed.
- 3. Equipment maintenance performed.
- 4. Road clean-up due to storms was performed.
- 5. The overhead lights at Route 38 and Route 68 are strobing. The lights are scheduled to be fixed at no cost.
- 6. A Right-of-Way and Easement Agreement with a property owner to remove two trees at the intersection of Hinchberger Road and Freeport Road has been obtained.

# **ADDITIONAL BUSINESS**

Rick Green motioned to advertise that the Multimodal Transportation Grant for the Bonniebrook Road project will require all bidders to be certified by the State. Willie Adams seconded the motion. Motion Carried Unanimously.

# **OPEN TO THE FLOOR – PUBLIC PARTICIPATION.**

Anthony Gagliardi attended the meeting to discuss his property at 880 Herman Road. Mr. Gagliardi has a stormwater management plan for a future development at this location. However, he determined that the required 50' right-of-way and slope for a development cannot be met and has decided not to pursue a development at this time. He has installed a road to access the back of his property for the hauling of shale and dirt from the property. The Supervisors will request the Township engineer and Planning Commission to research the requirements for the road and if the current stormwater management plan meets the requirements for the road and excavation activities.

Anthony Dellatoffala of 122 Bricker Avenue brought to the Board's attention that vehicles are scraping upon entering and exiting his driveway due to the paving project. He requested that the Township fix the issue. Also, he is concerned that the Township over trimmed a large oak tree on his property. He was notifying the Board that if the tree dies, he wants the Township to be responsible for the removal.

The Township's Solicitor will be contacted for the meeting date with Summit Academy to discuss students leaving the premises without permission.



#### **ADJOURN**

With there being no further business to come before the Board of Supervisors, Rick Green made the motion to adjourn. Willie Adams seconded the motion. Motion Carried Unanimously. Meeting adjourned at 7:30 p.m.
