Many of our members now work from home so we need to make sure we retain jurisdiction in these new areas and that our members are compensated appropriately. After January 6, 2021, and the ongoing pandemic, the safety and welfare of our members is of paramount concern to us and we are communicating with your employers on a regular basis to ensure they are following proper protocols with regards to safety.

As for our individual units this is where we stand:

- 1. ABC Network contract talks have begun at the level of the network negotiating committee, who are meeting to discuss rules and proposals. Our negotiator at NABET-CWA Local 31 is rank and file member Alex Staherski and Sector President Charlie Braico will be the Union's chief spokesperson.
- 2. NBC Network operations has moved to 400 North Capitol Street after over seventy years at their Nebraska Avenue location.
- 3. WRC Comcast Sports is moving to Nebraska Avenue sometime this year and will be sharing space with WRC. We welcome a new WRC Executive Board member, Nick Leimbach.
- 4. NPR Reports they are in better financial shape than they had projected.
- 5. PBS Status Quo

- 6. WJLA We are scheduled for an arbitration on April 27, 2021 concerning dues payments.
- 7. WHUT Status Quo
- 8. MCM/MCT Working under the newly ratified contract of December 2020.
- 9. HRS The contract has reopened, and the negotiating committee is meeting to discuss proposals. The committee members are Doug Koztoski, Todd Baham, Carl Mayers, Bob Williams, and our attorneys Keith Bolek and Rebecca Richardson.
- 10. SRS Status Quo
- 11. Maslow Lobbying efforts will resume with the House Committee on House Administration concerning pay parity. Also, we welcome a new Executive Board member, Tyrone Riggs.
- 12. WSVN We welcome a new Executive Board member Don Hansen.
- 13. HCS The contract is reopening and expires March 31, 2021.
- 14. WITF We would like to have an Executive Board member from this unit.
