In addition, the requestor agrees to fully indemnify and hold harmless the Borough of Glassport and assumes all liability for damages or injury occurring to any person or property through or in consequence of any act or omission of anyone associated with the placement of the waste dumpster or street storage container on the roadway.

Requestor has obtained and attached a certificate of liability insurance in the minimum amount of \$50,000.00, and named the Borough of Glassport as an additional insured on said policy for such purpose. In the alternative, Borough Council may, in its discretion, waive this insurance requirement if the person requesting a permit to place the dumpster or street storage on any street (1) provides proof of homeowners or renter's insurance that will provide coverage in the event of any property damage or personal injury and (2) the person requesting the permit signs the Indemnity Agreement attached to this Application in which Requestor agrees to indemnify and hold the Borough harmless in the event of any property damage or personal injury.

If so, a certificate of insurance covering the use of the chute or similar device or object and naming the Borough as an additional insured must be provided. If a chute or similar object or device is to be erected, constructed or utilized, it must be approved by the Building or Code Official and listed on the Insurance Certificate.

**BOROUGH OF GLASSPORT**  
**WASTE DUMPSTER/STREET STORAGE CONTAINER CRITERIA FOR PLACEMENT**

The placement of a waste dumpster or street storage container on a roadway within the Borough of Glassport may be permitted providing the following criteria are satisfied:

1. The requestor has no other available space (driveway, lawn, etc.) that the waste dumpster or street storage can be placed.
2. The waste dumpster/container will not be placed on the roadway longer than two (2) weeks and will not be placed upon any pedestrian sidewalk or walkway.
3. The waste dumpster/container will be removed within 24 hours of it being filled.
4. The waste dumpster/container will be secured so as to prevent debris from the container from blowing from or spilling from the container.
5. At all times, including those times when work is not being performed at the waste dumpster, the waste dumpster and its refuse contents must be maintained in a manner to assure that the contents of the waste dumpster may not be invaded or removed by animals, vermin, vandals, scavengers or trespassers and in a manner to assure further that persons occupying residences or other buildings or structures contiguous to, or adjacent to, the waste dumpster location will not be annoyed by noxious odors, noise, airborne pollutants or other elements or characteristics of the waste dumpster.
6. Traffic control devices will be properly placed and maintained to alert and warn drivers of the potential hazards created by the placement of the container.
7. The requestor completes an application requesting the placement of the waste dumpster/container and agrees to the conditions and requirements associated with such request.
8. The requestor pays a \$\_\_\_\_\_ application fee.
9. The request is approved by the Chief of Police or his designee.

NO waste dumpster or street storage container will be allowed to be placed in any area that a motor vehicle would be prohibited from stopping, standing or parking by either ordinance or statute. (Unless articulable circumstances present and only upon approval of Chief of Police or designee)

Traffic Control Devices:

1. Traffic control devices shall be placed when the waste dumpster/container is placed on the roadway, and they shall be properly maintained by permittee during the time they are placed.
2. Traffic control devices shall remain in place only as long as they are needed, and they shall be removed as soon as possible thereafter.
3. Traffic control devices shall be correctly positioned, clean, legible, operative, and in good state of repair. The reflective sheeting is not permitted to be scratched, scarred dirty or

show evidence of loss of reflectivity. They shall be repositioned, cleaned, repaired, and replaced when necessary to maintain their effectiveness.

4. Devices shall be positioned to provide for a smooth and gradual transition of traffic around the waste dumpster/container.
5. Devices shall be constructed so as not to inflict undue damage to a vehicle that strikes them inadvertently.
6. Only cones (28"to36"), drums, Type I or II Barricades, or minicades shall be used as traffic control devices. Devices shall have reflective sheeting.
7. In addition to the traffic control devices, the waste dumpster must display reflective material mounted on each of its corners.
