

First Presbyterian Church Furniture Ministry



For almost 30 years, First Presbyterian Church of South Charleston has spearheaded the Furniture Mission. In co-operation with Heart & Hand, participating churches pick up and store donated furniture every other weekend from late May through August each year.

Other churches currently supporting this ministry are First Baptist, First Methodist, Genesis Fellowship, and First Nazarene.

Each church has one or two Saturdays during the summer on which it has three volunteers pick up donations and deliver them to a storage shed on the FPC parking lot. Heart & Hand then distributes the donations to local people in need. Pick up hours are about 8-1, with one person driving a truck rented by FPC.

April 2024 Session Digest

WORSHIP (W): On April 7, RLPC had an estimated 41 communicants between on-line and live. The next communion celebration will be May 5.

If you are joining worship at home that day, please remember to prepare

your elements in advance.

ADMINISTRATION & FINANCE (A&F): The balance sheet general account has about \$76,000. The March Budget vs Actual has a balance in March of \$3,922, and YTD about \$1,000.

CHRISTIAN NURTURE (CN):

MISSION & SERVICE (M&S): Preparations are underway for the Pentecost offering.

PROPERTY (P): Several members worked on April 13 to clean up debris from the April 11-12 heavy storm. The Rock Lake Community Life Center (RLCLC) had more extensive damage, and the church has submitted a claim to our insurance company. The Pollen8 purchase of the hollow property may be affected, as Pollen8 did not have 'renter' coverage on their flood-loss furnishings at the RLCLC.

CONGREGATIONAL CARE (CC): The next Sunday potluck will be May 19 (moved to avoid conflict with Mother's Day). Don't forget, the most important ingredient is Y-O-U!

OTHER: Session approved a motion from the sign committee for a two-faced LED sign to replace the existing point sign at the corner of Village Drive and Kanawha Turnpike. The project cost is about \$29,000 and will be paid from memorial funds.

RLCLC Flooding

Summary of actions subsequent to the flooding at Rock Lake Community Life Center (RLCLC) on Thursday, April 11, 2024.

April 12 - Cheryl Laws, Pollen8 CEO, called Ken about 7:45am asking if RLPC has flood insurance. Ken was not sure, but told Cheryl he would check. Cheryl confirmed that their policy does not have flood insurance. She also asked if it would be possible to move the Appalachian Behavioral Health Care (ABHC) operation to the church while the RLCLC is remediated. Furniture was being removed to the back concrete pad, and a remediation company had installed dryers to dry the floor. Ken arrived at the RLCLC later that morning. Most of the furniture on the ground level was already on the pad. Cheryl said that she had arranged to move the ABHC to the St. Paul United Methodist Church on Kanawha Turnpike while the RLCLC was unusable. Pollen8's damage estimate is \$75,000. Ken later called the Smith-Carpenter Agency (S-CA), our representative to The Insurance Board and spoke with receptionist Nancy. She advised that Jeff Carpenter, our agent, was out of town, but she would forward Ken's questions to him.

April 15 - Ken reached out to S-CA and left a request for a callback. He gave particulars about the RLCLC to Nancy when she called back.

April 16 - Ken left a message with S-CA for another callback. Jeff Carpenter called back on his cell phone. Ken asked Jeff if the church has flood coverage on our policy and if Jeff could send him a copy of the current 2024 memorandum of insurance (MOI). At that time, Jeff did not have internet access, so he said he would try to get internet, check on coverage and MOI. After that conversation, Ken called church treasurer Mary Wagner, who forwarded the 2024 MOI to him. Ken reviewed the MOI, and thought that we did have flood coverage, so he texted Jeff, asking him to call back when he had a chance to review the MOI. Jeff called back about noon, reporting that RLPC did have flood coverage. Ken reported that in an email to the session. At the April session meeting Tuesday evening, Ken reviewed the sequence of events. It was decided that John, Ron, and Ken would call Jeff back after the meeting to initiate an insurance claim.

In a 3-way call John created about 9:15pm, John & Ron, at the church, conferenced with Ken at home, and Jeff Carpenter. We initiated a claim against the policy. Ken will be the primary contact. Jeff advised that Ken will get an email from a claims adjuster Wednesday, and will get a phone call from an unknown contact, so Ken should answer unknown calls until he gets that call. Jeff also advised that he will now be out of the claim loop.

After that phone call, Ken tried to call Cheryl, and wound up leaving a message advising her that a. RLPC does have flood insurance, b. we have initiated a claim, c. he was going to bed.

April 17 - Ken followed up with a similar text early Wednesday morning, letting Cheryl know he would be available until 7:30am if she wished to call. Cheryl did call at about 7:10am. They agreed to meet sometime Wednesday afternoon, both having other morning obligations. At 11am, Ken texted Cheryl that he was back home, and asked Cheryl if they could meet at the RLCLC. They agreed to meet there at 12:30pm.

At about 12:10pm Wednesday, a woman named Brenda Cerrone called Ken. She said she worked with the adjuster, and would be our contact through this process. Ken got her phone number, but not all of her contact info (he later found out Brenda works for Travelers Insurance). At 12:30pm, Cheryl, Pollen8 COO Hollie McCraw, and Ken met to discuss the situation. Ken brought hard copies of an email from The Insurance Board containing a hand-holding cover letter going through what to expect, and an outline of the claim's current details. Ken will contact Cheryl when the insurance adjuster calls him sometime in 24-48 hours. Cheryl, Hollie, Ken will arrange a time to meet the insurance adjuster after he calls Ken. Ken also told Cheryl and Hollie that the session took no action on the latest hollow property price proposal from Pollen8, thinking that we need to concentrate first on recovering from the storms of last Thursday.

April 18 - Chris Kwiatkowski called Ken about 10:30am. He is an inspector with Travelers Insurance, and works with Brenda. He advised that our tenant's (ABHC) furnishings would not be covered; the building will be inspected. Because Chris would have to drive 4 hours from his home and back, he is contacting a local inspector, Cindy Sikora, to do the inspection in his place. Ken called Cheryl to let her know that the RLPC coverage will not cover ABHC furnishings.

Cindy called Ken about 2:15pm, advising that she would be available April 25 at 9am for the inspection. After a round of phone tag, Ken initiated a 3-way call with Cindy and Cheryl at 4:10pm, at which time we settled on Wednesday, April 24 at 2pm for inspection. Cindy emphasized that she has a morning inspection at Yeager, so she did not want us to be upset if she is delayed. She will contact Ken if the morning inspection delays ours.

April 24 - The inspection was carried out about 1:30pm with Cindy, Cheryl, Hollie, and Ken attending. RLPC has now submitted requested documentation. The remediation company hired by Pollen8 is also submitting their bill for evaluation. As of April 29, this is the current state of the events resulting from the flood damage at RLCLC.
