OLD BUSINESS

Mike Gentry presented his draft – overcrowding swim hole. Need to be aware of riparians and possible keyholing – difficult to travel counter clockwise due to swim hole crowded. Deerfield does not have an ordinance officer – Rick will contact attorney to verify the document drafted should be posted or not due to liability repercussions. It is recommended to post the ordinances as written from Deerfield and Argentine Township.

NEW BUSINESS

House Bill 5532 – wake boats – proposal to 20 foot depth and 500 feet from dock. Several states and Canada have law in place. Senate Bill – allowing temporary fluctuation of water level. Going to House for vote – will protect LBLA from potential lawsuits. Orchard Park drainage project is court mandated in Tyrone Township. Homes in subdivisions at Linden and Bennett Lake Road area were flooding. New drainage design will have water going through three different retention ponds and two different wetlands before it goes into Hoisington.
