An unfortunate decision, many members within the Kingsway Branch had contributed extensive personal time to meet the requirements

There was an administrative error in submitting the GEPF poppy supplies order this year, this has been corrected and should arrive within the next few weeks. The Kingsway Branch's current supply of poppies is sufficient for this year's campaign & there is a reasonable inventory of ancillary supplies for the remainder of items (i.e., rolls of poppy stickers). The poppies required for the Kingsway 2023 campaign have been packaged & are ready to be distributed, when the Business builds take place in late October with supporting volunteers. I have informed the other Branch's should they wish to get a jump on packaging poppies for distribution, that there is a backup supply of poppies held in the sea can (GEPF supplies not Kingsway's).
