# **MPD** Community Report

**Discussion and possible resolution on Council proposed bill B25-0475 "Initiative Amendment Act"** The bill would prohibit citizen initiatives from being on the ballot if they would require appropriations in order to be implemented. Council representatives have been invited to speak about the proposed bill. Over 50 ANC Commissioners have signed a letter opposing the legislation.

# Presentation on New Exhibit and Programming on Redlining and its Legacy in Ward 3

An interactive exhibit at Cleveland Park Library, 3310 Connecticut Avenue NW, will be open through July 11, called "Undesign the Redline DC," organized by a community advisory group and a planning team from houses of worship in Ward 3, including St. Columba's Episcopal Church, Adas Israel Congregation, Temple Sinai, Temple Micah, Chevy Chase Presbyterian Church, and St. Paul's Lutheran Church. The exhibit explores the history of redlining and displacement of communities of color in upper NW DC and also presents stories of vision and change to inspire others to take positive action. # Presentation on KRF Neighborhood Partnership Program in the District and Surrounding Areas

The KRoussaw Foundation, recognized with a Mayor's Award for Excellence in the Humanities, was founded by educator and business consultant Kilil Roussaw to provide activities for young people from elementary through high school and beyond. It builds on his commitment to education to create opportunities outside the classroom such as after-school and summer camps, S.T.E.A.M., English literacy, and entrepreneurship training, and mental health services, with the hope of making a lasting difference in the lives of both the students and the people in the community.

**Presentation and Resolution on Pepco application for 3-year rate increase in Formal Case 1176** Assistant People's Counsel Ankush Nayar will speak about the current Pepco rate case before the DC Public Service Commission (PSC). Pepco has asked the PSC to approve a new multi-year rate plan (MYP) which would result in a 3-year increase in electric rates of \$190.7 million. On March 12 the Office of the People's Counsel (OPC) joined the DC Government and the Apartment and Office Building Association (AOBA) in filing a Joint Motion to Dismiss Pepco's request for the MYP on the basis that it is structurally deficient and premature. Public comments on the Pepco request are due by April 26 to <u>PSC-CommissionSecretary@dc.gov</u> The ANC may consider a resolution on this case.
