#### Introduction and Report by MPD Captain Tatjana Savoy (Second District Sector II Captain)

#### Presentation by Ward 3 Board of Education Member Eric Goulet

Mr. Goulet will speak about his priorities for improving education and funding for schools in Ward 3.

#### Vote on Resolution Regarding Funding for DCPS Schools in FY2024

DCPS has released initial budget allocations to local schools for the coming year, which call for 5.26% cuts for Deal Middle School and all five elementary schools that are in-boundary for ANC 3A residents.

#### Vote on Resolution Regarding Investment for Expanding Capacity in DCPS Schools in Ward 3

Board of Education member Eric Goulet has asked the ANCs in Ward 3 to support his proposal for the former Intelsat headquarters at Connecticut Avenue and Van Ness Street NW (most recently the site of the private Whittle School) to be used for District schools, including potentially pre-K3 and pre-K4, a middle school and/or high school. Several ANCs in the area have adopted letters asking the District Council, Mayor and DCPS to explore options for acquiring the Whittle School campus for public education. The Commission will discuss that subject, ask for comments and consider a resolution.

#### Vote on Resolution Regarding Improvements to Bus Transportation to MacArthur High School

The Commission will take comments on public transportation available for students from the ANC 3A area to attend the new high school on MacArthur Boulevard opening in August 2023, and vote on a proposed resolution to Councilmember Matt Frumin, the Mayor, Council, DDOT, and WMATA regarding the need for additional bus service and associated funding for students to get to and from the new school.
