## **Monthly Community Report from MPD Second District**

#### Presentation on AU sports buildings proposed on tennis courts at west edge of campus

Cory Peterson, AU Assistant Vice President of Community and Government Operations, and Maria Barry, AU Director of Community Relations, will present the proposal for two new sports buildings on the campus. Zoning Commission approval is required for a further "Processing application" on the Main Campus, under the 2021 AU Campus Plan approved by the DC Zoning Commission in ZC Order No. 20-31, which became effective on April 8, 2022.

# Resolution Regarding School Transportation for Students with Special Needs

The DC Office of the State Superintendent of Education (OSSE) is responsible for providing transportation for special needs students across the District. In recent months, OSSE has been the subject of multiple reports by parents, guardians, and others about failures to provide timely and safe transportation for students who are signed up to receive these services. The Commission will consider a resolution urging priority attention to these problems for students, families and caregivers.
