#### **MPD** Community Report

Local police officials have been invited to speak about recent experiences in MPD's Second District, including a series of robberies and carjackings or attempted carjackings.

# **Presentation on zoning request to build a garage at 3523 Porter Street NW (BZA Case 21045)** Applicants will present the application for a zoning Special Exception to allow construction of a garage on the rear alley, in the R-2 zone. The property is in the Cleveland Park Historic District, in ANC3A03. The BZA has scheduled a hearing on the case on January 31, 2024. The ANC invites public comments, and plans to consider a position on the case at its January meeting.

### Discussion of resolution on proposed No Parking/loading zone in front of 3601 Wisconsin Avenue NW

DC DDOT has issued a Notice of Intent (NOI-23-237-TOA) to change the remaining two-hour parking space in front Crestview Condominiums to a No Parking/Entrance (Loading) Zone. DDOT recently installed a new Metrobus stop in front of the building, removing 4 two-hour parking spaces and the previous loading zone near the building entrance. Comments are due to DDOT by December 22.

#### Presentations by Washington Gas and OPC on WGL's PROJECTpipes to replace gas infrastructure

PROJECTpipes is a 40-year program launched in 2014 to replace virtually all the pipes used to distribute natural gas to District customers, paid for by surcharges on gas bills. Washington Gas has asked the PSC for approval of a proposed \$672 million Phase 3 for the next 5 years. Since the project started, the District has adopted policies calling for reduced use of fossil fuels (including natural gas, which is primarily methane), with a target of "net zero" carbon emissions by 2045. Washington Gas and the DC Office of the People's Counsel will both make presentations on PROJECTpipes. The ANC may consider a resolution to the PSC.

#### Proposed Resolution on Proposed Protected Bike Lanes on Connecticut Avenue NW

After three years of community outreach and study, DDOT announced in December 2021 that it would move forward with a protected bike lane on Connecticut Avenue from Legation Street in Chevy Chase to Calvert Street in Woodley Park. The decision to move forward with Option C was announced by Mayor Bowser and the Mayor called it an important part of making our city "greener and safer." Since then DDOT has missed several project milestones and has been silent about its plans and reasons for the delay. The ANC may consider a resolution similar to resolutions adopted by other ANCs in Ward 3 urging the city to move forward with its previously announced plans.

# [The following agenda item was deferred because the intended speakers indicated they had a schedule conflict, and earlier in the day the Commission learned that DCPS had resumed negotiations with WTU:

**Presentation by Eric Goulet, Board of Education, Ward 3, on DCPS contract negotiations with teachers** The contract covering DCPS teacher salaries and benefits expired in October 2023, and the contract with other school officers will expire in October 2024. The State Board of Education adopted a resolution in October urging DCPS to open negotiations with the Washington Teachers Union by January 1, with the hope that new contract terms can be taken into account in DCPS funding formulations and the Mayor's proposed budget which will be presented in early spring for school year 2024-2025. DCPS and WTU were also invited to speak.
