#### Police Report

##### **Presentation on proposal for 5-story 23-unit apartment building at 3427 Wisconsin Avenue NW**

The plans for the project are under conceptual review by the DC Historic Preservation Office. The ANC has been asked if the project is of interest for review, and it may be a subject for future comments. The property is in the Cleveland Park Historic District, on Wisconsin between Norton Place and Ordway Street in the RA-2 zone. It is part of Commissioner Hans Miller's Single Member District (ANC3A03).

##### **Presentation on proposed project at historic landmarked home at 3550 Tilden Street NW**

The homeowners will present their proposal for public information. The project in ANC3A03 does not require zoning approval but has been presented to the DC Historic Preservation Office for conceptual review of the plans, which affect rear and side windows and add a skylight at the back. All applicants are encouraged to share their plans with the ANC, which is responsible for notifying the community.

##### **Proposed letter to DPR RE community engagement on arrangements for private use of park facilities**

Recent reports of a proposal to DC Department of Parks and Recreation (DPR) for use of the field at Hearst Park and installation of artificial turf there by for-profit Player Progression Academy (PPA), a youth soccer training program, have raised comments and questions about the DPR process for reviewing and refining proposals of this kind. The PPA proposal is not yet available to the ANC or the community, but the Commissioners are interested in potential input on DPR plans for community engagement.
