## Proposed Agenda for ANC 3A Special Meeting

Discussion of two DC Department of Transportation (DDOT) Notifications of Intent (NOIs) designed to improve safety on Wisconsin Avenue NW, which is a "High Risk Corridor":

- moving two Metrobus stops on the east side of Wisconsin Avenue (one at Porter Street and one at Upton Street) from the south side to the north side of the intersection
- removing the Metrobus stop on the east side of Wisconsin at Macomb
- adjusting parking on Wisconsin to adjust to the changes in the bus stops (creating parking spaces at the current locations of the bus stops and removing parking spaces at the new locations of the bus stops in the 3200, 3600 and 4000 blocks of Wisconsin Avenue)

The Commission will take public comments and consider a potential resolution to send DDOT.
