Eyes and Ears – Neighborhood Watch – E&E ALERTS

E&E alerts are our way of spreading the word, via e-mail, about suspicious activity going on in the neighborhood. The more eyes and ears on the street, the better chance we have of averting people who want to do us harm or destroy our property. Neighbors who send the E&E alerts should call the Salinas PD non-emergency number (758.7321) to report the activity. It is very important to alert the SPD as to what is going on so appropriate action can be taken. You can report it anonymously or request a call back. Remember: SAFETY FIRST! Do not put yourself in danger. SPD wants us to call so they can do their job.

Noise Complaints & Loud Parties

Contrary to popular belief, loud noises do not have to be tolerated. There isn't a "free" period where parties or loud noises are acceptable during certain hours or up to a certain decibel. According to the SPD, "Class D Noise is defined as noise that is unnecessary, unnatural or unusual noises created by a human voice or animal outcry, or by any other means which is so annoying, or which is so harsh or prolonged, as to be injurious to the health, peace or comfort of any reasonable person residing in the area. **Class D noise is not permitted at any time.**" The key here is to be considerate of others around you. No one wants to prevent you from having fun, but there is a time and place; for example, midnight or 4:30 a.m. are not appropriate times, and neither is operating a karaoke machine in the middle of the night.

What laws are being broken if I give a loud party and refuse to lower or stop the noise?

There are several laws that may be broken if you are responsible for giving a party that is too loud. **California Penal Code (415.2)** states it is illegal to maliciously and willfully disturb another person by loud and unreasonable noise. **Salinas Municipal Code** states it is illegal to use any sound equipment between the hours of 10:00 p.m. and 8:00 a.m., or at any time when it is unreasonably loud **(21A-16)**. It is also a violation of the Salinas City Code to willfully make any loud, unnecessary, or unusual noise which disturbs the peace or quiet of any neighborhood **(21A-22)**. You could be issued a citation or be subject to arrest for a violation of either of these codes.

DOOR-TO-DOOR SOLICITORS

Salinas PD has warned the public about people posing as salespersons for Kirby vacuum cleaners, magazines, or grease/spot removers. These would-be salespeople have been casing residences with intentions to later burglarize them. It is not against the law for Kirby or others to send salespeople door-to-door, but it is your choice to invite them in to demonstrate their product. However, we cannot be too careful when it comes to opening our doors to people we don't recognize. Should you choose to open your door, you may ask the solicitors to produce their City of Salinas Solicitor's Permit, Business License, and photo identification. Without the license, it is illegal for them to sell to you. Police recommend posting a No Soliciting sign. It is a citable offense to disregard the sign. SPD also recommends calling 911 if the person refuses to leave your residence. If people you don't recognize knock on your door, don't open the door, but be sure they hear you say something, such as "not interested". This is so if they are casing the area, they know someone is home and they will move along.

CITIZEN PATROL

- LORNA has begun Citizen Patrols to help assure safety in our neighborhoods. You may have seen neighbors on patrol wearing LORNA fluorescent green vests.
