- 3. Guarantee is void if: the puppy is not examined by a licensed veterinarian within 3 business days or in cases where the puppy is mistreated, malnourished, or abused. Guarantee is non transferable if puppy is sold by buyer. It is understood that at the time of this sale, this puppy is represented as its breed and suited as pet quality, not for show or breeding. This guarantee is void if the puppy has been bred, altered, transferred, or euthanized without the seller's written consent.
