Dear Neighbors,

Welcome to the fall season of pumpkin spice and all things candy corn. Autumn is a lovely change of season from humid days to cool nights. It also means schools are back in session and fall sports have begun which alerts us to notice the students crossing Charmuth

Road, and drivers parking around the school. Please remember to be aware of the hustle and bustle of the neighborhood.

Inside this newsletter is a message from the zoning committee, I would like to take this time to thank *Tim Ruppalt, Max Collins, Dr. Bob Cordes*, and *Susan Shaffer* for their dedication during the appeals process. Tim has written an update of what is occurring now since the appeal hearing, please read that message in this newsletter. At this time, we are preparing for the next step in the legal process. While we await the written verdict the zoning committee, with much research and writing by Tim is reading through the statements and combing through Baltimore County Code.

The cost of the legal process includes filing fees for the appeal(s). It also includes obtaining the transcript. While it might seem strange, it is how the court system in Baltimore County works. The fee is great since there are 8 hours of court testimony to have transcribed. The process is costly but a necessity for appeal. The purpose of appealing is the loss of due process during the DRC meeting. The community has a right to express its concerns to the developer regarding the project.

We are launching a fundraising period for the community; many can recall the first large in-person meeting when back in where we first heard about the new owners and lead astray with the apartment complex plan and saw renderings for the site across the street; at that meeting many neighbors stated they would eagerly assist the community financially to fight the development of the property. Now is the time to assist.

A few years ago, a PayPal link was added to the website enabling an online option for dues and donations. We hope to add a feature where you can opt-in to automatic annual payments for the dues or make a recurring additional donation. We have received contributions from surrounding community associations, and from people who do not live in the community but who understand the cost of this legal process. We need your help as well.

## Zoning Committee Update Update on the proposed development of a Royal Farms Store at York Road and Greenridge Road.

On August 24th the Board of Appeal (BOA) panelists met for public deliberation of our appeal. The panelists took 10 minutes to publicly discuss 10 hours of testimony. The BOA decided to only use a very narrow section of the Baltimore County Code. They ruled in favor of granting the developer the "Limited Exemption from Community Input and arbitration with an administrative law judge. We are awaiting the official written opinion.

We were not disappointed. Our lawyer told us this was the likely outcome in Baltimore County. The BOA suggested we pursue "other" jurisdictional remedies. This was already part of our long-term strategy. After reviewing the written opinion, we are prepared to challenge the zoning process. We believe Two Farms, the developer, has used the "Limited Exemption" process to circumvent an appropriate and necessary zoning review of twelve (12) Level 3 Tesla superchargers.

There is some good news. Bill 51-22 was passed in early July by the County Council. It was sponsored by Councilman Kach and two others. It passed unanimously. This Bill establishes that the Development Review Committee will meet the "Maryland State Open Meeting" requirements and provide proper notice to the community of a "Limited Exemption" request. Our hopes are this new law shakes up the Department of Permits, Applications and Zoning.

As we move forward, we will continue to need donations to pay our legal costs. We are requesting donations from inside and outside our own community association. If you would like more detail, please email any member of the Zoning Team.


