Entry Information

Exhibit at Capital Arts Gallery, 1203 Missouri Blvd. Jefferson City Mo

The annual Adult Fine Art Exhibit (AFAE) is for any amateur or professional artist above high school age and living within a 100-mile radius of Jefferson City, Missouri to enter two or three-dimensional fine art into a judged competition and exhibit. Sponsored by Jefferson City Art Club (JCAC) and Capital Arts (CA), it has been a tradition for many years. The ten Entry Fields include painting, drawing, photography, 3-D art and more.

The annual Adult Fine Art Exhibit is scheduled for Thurs. May 2nd-Sat. June 1st in the Capital Arts Gallery, 1203 Missouri Blvd., Jefferson City, Missouri. (Please note that all dates are different than last year). There will be an artists' reception which will be held Thursday, May 9, 5:00-7:00 pm.

Entries will be accepted from residents and artists within 100 miles of Jefferson City. As this is an Adult Fine Art Exhibit, high school and younger artists are not eligible to enter. Pre-entry registration is required using the enclosed form or via https://jeffersoncityartclub-missouri.com. No work will be admitted to the show unless we receive your registration by Monday, April 22nd. All artwork must be hand delivered between 11:00 am and 6:00 pm on Monday, April 29th, 2024.

Eligibility Classifications:

Professional

- A. Anyone who has earned an art degree in any area of art from a college, university, or accredited art school. or
- B. Anyone who earns at least 50% of his/her yearly income from artwork, or
- C. Anyone who teaches or has taught art classes for reimbursement, or
- D. Anyone attending graduate school in art, or
- E. Anyone self-identified as professional. (Once professional always professional)

Amateur

- A. Anyone who has had formal training of art in a college, university, art school or accredited correspondence school, but who has not attained any levels mentioned for professionals, or
- B. Anyone self-taught or having had limited training only through workshops or community art classes.

The Adult Fine Art Exhibit Committee may determine eligibility.

Entry Fields:

Acrylic Oil Charcoal/Graphite/Ink Pastel/Chalk/Colored Pencil Sculpture-3D Watercolor/Gouache Film Photography/Darkroom

Photo-based Digital Art Digital Art, not Photo-based

Artist's Choice: including Monoprint (no copies), Fabric, Mixed Media, or Egg Tempera (Specify medium)

Entry Rules:

- 1. Entry fee is \$15 per entry, discounted to \$7 for Jefferson City Art Club members only (not Capital Arts Members). Limit of 4 entries per artist. Entry forms and payment are due by April 22nd. to participate in the Exhibit. JC Art Club membership is \$25/yr. and may be paid now with this entry form and a membership form from https://www.jeffersoncityartclub-missouri.com if ioining.
- 2. Artwork must not have been shown within the past two years in any JC Art Club AFAE.
- Art must be original in design and execution by the registered artist. No copying and
 copyrighted images may be used in artwork provided they are significantly transformed into
 new creative art forms. Artist is solely responsible for copyright legal challenges. All artwork
 must be hand produced.
- 4. JCAC and CA reserve the right to reject artwork for any reason. Artwork and frames must be completely dry. No damaged or fragile artwork.
- 5. All 2-dimensional artwork must be framed, except gallery wrapped canvas with painted edges. Wire hangers only, no saw tooth or loop hangers. **Artwork without wire hangers will not be accepted in the show.**
- 6. Artwork may not exceed 144 inches in perimeter including frame. For example, a 48 inch by 24-inch artwork is the maximum size. (48x2=96 inches, and 24x2=48, 96+48=144 inches.)
- 7. Art must be for family viewing and adhere to Capital Arts Galley policy, no partial nudes, nudes, graphic violence.
- 8. Sculpture may be clay, metal, glass, wood, papier mâché or other media.
- 9. All entries are checked for meeting entry requirements, proper classification, and entry field on the tag. Any artworks not meeting requirements will be rejected.
- 10. Artwork must remain in the gallery for the duration of the show. If artwork is removed early all awards are revoked.
- 11. Capital Arts Gallery will retain 25% commission on sales made during the show. Payments are made to Capital Arts. Capital Arts will pay the artists less the CA commission after the show.
- 12. CA and JCAC reserve the right to use photographs of the artwork for promotion and advertising of Capital Arts, JCAC and the Exhibit. Submit images of artwork for its promotion by emailing JPEG files to artsadmin@capitalarts.org and cherylarti@aol.com and please note which show they are for. These images may be posted on the CA website and Facebook page, and on the JCAC Facebook page and Members-only webpages. Optionally bring Artist's Biography page for the bio book when dropping off the artwork. It should be one typed page with images if desired. CA and JCAC will do their best to display artwork in a complimentary fashion. We reserve the right to hang the exhibit as we see best.
- 13. No refunds will be issued.

Additional Information:

Artist assumes complete responsibility for insurance of artwork. All reasonable care will be given to artwork in custody of the Jefferson City Art Club and Capital Arts Gallery. Works submitted are at the artist's risk. The Jefferson City Art Club and Capital Arts Gallery are not responsible for damage or deterioration incurred before, during or after the exhibition. Artists/Exhibitors further agree to release and to hold harmless Capital Arts and The Jefferson City Art Club its officers, directors, presidents, employees, volunteers, and agents from all liabilities and damages to artwork and/or persons as a result of any part of Artist/Exhibitor's participation in the Exhibit.

Submissions of any entry in this exhibit constitutes agreement from entrant to the conditions above. If not for sale, indicate on entry form. Works are submitted at artists' risk.

Judging and Awards:

A judge is a qualified individual familiar with all classifications and judging is closed to public. Judges may award ribbons in each field within each classification for 1st, 2nd, 3rd place and Honorable Mention. A cash prize of \$100 and a ribbon is given to one Best of Show winner each in Professional and Amateur categories. The People's Choice Award for each classification will be voted on during the entire show. A People's Choice ribbon will be given at the end of the show.

Special awards in each Classification will be given to 1) a watercolor piece in memory of Florence Guhleman, a long-time member, past president, and well-known watercolorist; and 2) an oil piece in memory of Miki Claypool (1937-1956), a gifted oil painter and sister of the late Roberta Dunkel, and 3) an acrylic piece in memory of gifted artist Roberta Claypool Dunkel (1944-2023), long-time member and past president.

Winners will be announced on the CA and JCAC websites or Facebook pages and to the public.
