III. ENGINEER'S REPORT (Attach to Application)

Engineer's Report must be from a qualified and Mississippi licensed Professional

Engineer and must contain the following:

- 1) The tower height and design, including a cross-section and elevation.
- 2) The height above grade for all potential mounting positions for co-located antennas and minimum separation distances between antennas.

- 3) The tower's maximum capacity, including the number and type of antennas it can accommodate.
- 4) Evidence demonstrating that no existing tower or other structure can accommodate applicant's proposed tower, as detailed in Section V.1.0 (b) on Page 14 of the City of Florence Telecommunications Tower Ordinance.
- 5) Documentation of the steps Applicant will take to avoid interference with established public safety telecommunications.
- 6) Copy of Certification from FCC that site plan and proposed tower meet all federal standards for health, environmental and safety.
- 7) Copy of certification from FAA that site plan and proposed tower complies with all federal regulations administered by FAA.
- 8) Statement of compliance with structural and electrical requirements of the Telecommunications Towers Ordinance of the City of Florence.
- 9) Engineer's stamp and registration number.
- 10) Any other information that will assist in evaluation of this application.

IV. SHARED USE LETTER OF INTENT (Attach to Application)

Application must include a Letter of Intent from Applicant, committing the Tower Owner, and Successors, to shared use of the Tower so long as additional user/users agree in writing to reasonable terms and conditions for shared use.

A. SITE OWNER AUTHORIZATION

Application must be accompanied by Letter of Authorization from Site Owner the he/she concurs with the application.

V. FUNCTIONALLY EQUIVALENT SERVICES

In the event functionally equivalent services are proposed, Applicant must provide evidence as to why such services are, in fact, considered functionally equivalent.
