## NOTICE OF 2023 TAX YEAR PROPOSED PROPERTY TAX RATE FOR THE TOWN OF EDGECLIFF VILLAGE

A tax rate of \$.267425 per \$100 valuation has been proposed for adoption by the governing body of the Town of Edgecliff Village. This rate exceeds the lower of the no-new-revenue tax rate or voter-approval tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate. The governing body of the Town of Edgecliff Village proposes to use revenue attributable to the tax rate increase for the purpose of paying annual maintenance and operations as it relates to public safety, community services, and general municipal government and administrative functions.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of the property tax revenue for the Town of Edgecliff Village from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval tax rate is the highest tax rate that the Town of Edgecliff Village may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that the Town of Edgecliff Village is proposing to increase property taxes for the 2023 tax year.

A public hearing on the proposed tax rate will be held on September 08, 2022 at 1605 Edgecliff Rd., Edgecliff Village TX in the Edgecliff Village Community Center.

The proposed tax rate is not greater than the voter-approved tax rate. As a result, the Town of Edgecliff Village is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of the Town of Edgecliff Village at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

Property tax amount = tax rate x taxable value of your property / 100

The  $86^{\rm th}$  Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
