

3/ MASSIVE CHANGE IS COMING TO OUR AREA WITHIN 3-8 YEARS!

b/ There are MANY concerns we've raised when AWRA found out a few months ago, and we are actively continuing talks with the City. We've also added Sue Shillow and Lisa Diner as additional AWRA development committee members, in addition to Eric Casper and Roman Komarov to reflect more time and effort demanded of these multiple applications.

Some change is welcome, but there appears to be no respect for our community, and the character of our neighbourhood is under attack! Some of our concerns are noted below....

- many of the proposed towers are way too tall as spec'd by the developers, and will visually take away from the character of the existing area and the skyline.
- the additional demands on the Thornhill Community Centre, already way over the designed capacity and the heaviest used CC in all of Markham, have not been addressed by the developers or the City.
- the approx. 2,100 units will add more vehicles to the already congested traffic near John St. and Bayview Ave and Green Lane... and this is not including the future traffic congestion which will come from the 30,000 population from the Langstaff development when it's complete in 10-15 years.
- the developments are taking away from our green space, with no adequate replacement.

City planners are in the process of considering the proposals, and will come up with their recommendations. Only when Staff make their recommendations will residents be able to provide feedback. But area ratepayers associations believe that these proposals should not even be considered as they do not respect the character of the area. AWRA will keep you abreast of the projects as they evolve and will solicit your support in lobbying as required.

4/ COYOTES & FOXES ARE ON THE MOVE - BEWARE, ESPECIALLY FOR YOUR PETS!



Foxes and coyotes are an important part of our shared, local ecosystems. Typically, foxes and coyotes are unlikely to initiate contact with people. But we understand, occasionally, they get too close for comfort.

Limiting human food sources is the best way to prevent encounters with these animals - but, most importantly, to help keep them wild:

- Do not put out food for animals.
- Keep waste in secure bins or store bins in a secure building or container.
- Do not put waste bins out until the morning of pick-up.
- Make sure outdoor compost containers are wildlife-proof.
- Remove fallen fruit from trees and scattered bird seed from feeders.
- Keep pet food inside, and do not leave small pets outdoors unattended.

If you do encounter a coyote or fox who does not run away immediately, you can do the following:

- Make noise, yell, clap your hands, stomp and wave your arms.
- Do not approach the animal.
- Carry a whistle or noisemaker if you are walking in known habitat areas.

If you find that the animal is sick or injured, please report it to our wildlife service provider, by calling 905.310.7722. It is also important to keep your furry family members safe. Keep your cats or small dogs indoors or supervised outside. Walk your dogs on a leash and do not leave them out unattended, otherwise they may become a meal for the wild animals.

The O.P.P. and City bylaw people are actively involved, and we need to keep up the pressure on them to intercede with the owners of the shops and vehicles.

8/ UPDATE on the MAPLE VALLEY PARK TRAIL ACCESS:

Our Councilor Keith Irish is in the midst of negotiations with regards to repairing the embankment and constructing a new bridge for the Huntington Park pathway over German Mills Creek. The safety aspect of this project has taken a priority over the contemplated Maple Valley Park Trail Access project.
