

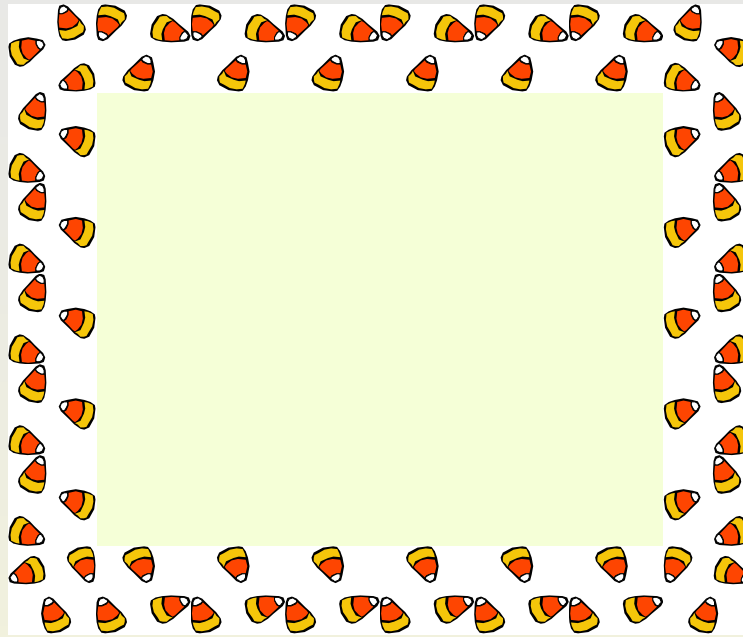

### COPMEA OFFICE INFORMATION



- ⇒ Transactions are cash or check
- ⇒ Disneyland, Knott's Berry, Six Flags, and Universal require purchase by credit/debit card
- ⇒ Knott's Berry charges a processing fee of \$5.99
- ⇒ Six Flags charges a processing fee of \$8.99
- ⇒ No charge for Disneyland or Universal.
- ⇒ \$50 fee charged for all returned checks
- ⇒ Have your COPMEA cards ready when making purchases
- ⇒ Tickets for monthly events are restricted to your membership
- ⇒ Take your old membership card to the COPMEA Office for replacement if your social security number appears on the card
- ⇒ Report any membership and address changes to the COPMEA Office

### CITY OF PHOENIX EMPLOYEE MONTHLY MEMBERSHIP

\$4 single monthly membership dues  
\$8 family monthly membership dues  
Monthly payroll deductions for fulltime and temporary city employees.

#### ASSOCIATE ANNUAL MEMBERSHIP

\$48 single annual membership dues  
\$96 family annual membership dues  
Non-city employees and city of Phoenix retirees may join COPMEA. Dues are paid in full for the year at the time of joining then annually thereafter.

#### Membership rules:

- ⇒ You must be a member to purchase tickets or participate in COPMEA functions
