CARES Act for 2020

According to the Coronavirus Aid, Relief, and Economic Security (CARES) Act, annuitants are not required to take a RMD in 2020. The Act includes a provision permitting a one-year delay in RMDs. Thus, any distribution that would otherwise be due this year would be deferred to next year; and, likewise, distributions due in later years would also be deferred. Notably, the CARES Act allows account owners to skip both their 2019 RMD if it was their first year and they had not yet made an RMD by April 1, 2020, and their 2020 RMD.

Under this act, if you have taken your RMD for 2020 yet prefer to return the RMD amount to your CLC policy, you may do so at this time. The return amount will be marked as a ROLLOVER to ensure there will be no tax implications for 2020.

Notices are being mail to all members eligible to take advantage of this Act. Please keep an eye out for your letter so you can make the right decision for you.
